


# **II. Student's Achievements**

# **ACADEMICS** (International)


Our students showed their mettle in International competitions also. Surely, they are going to take our Law School to new heights.

#### **LEGAL AID**

With the aim of providing legal mindfulness, social awareness and learning at the professional and grassroot level of application of law, the LEGAL SERVICES CLINIC of Department of law organized many awareness drives, *Nukkad Nataks* as well as orientations and webinars. Through such platforms our students who are Para legal Volunteers (PLV) showcase the burning issues in the society and suggest their solution also. The Clinic has been actively engaged in providing legal awareness among the less privileged sections in the locality around our Institute.

Our Legal Aid cell has won many laurels while enacting *Nukkad Nataks*. Our students won the Inter College *Nukkad Natak* Competition on 26<sup>th</sup> February, 2020. A group of 10 Para Legal Volunteers accompanied by Faculty convener Mrs Purnima Gupta participated in this event which was organized by Delhi State Legal Services Authority (DSLSA) and Bhagidari Jan Sahyog Samiti (Regd.) in association with National Service Scheme and All India Mantavya Foundation.

Our students performed an Act on Gender Equality and Violence on Women and Acid Attack, in an attempt to raise awareness among the masses and also tried to give possible solutions through our act. The moving performance carried itself to the audience and received lots of appreciation from the judges as well as the participating teams. Being law students, we have all heard about the incidents in the newspapers and laws in our textbooks, but the *Nukkad Natak* gave us a much better understanding about the agony faced by women and the remedies available to them.















#### **MOOT COURT**

Mooting is an indispensable part of law curriculum. The benefits of Mooting are multifaceted as it familiarizes students with court procedure, develops their argumentative skills, and develops their analytical, research & drafting skills. MAIMS, Department of Law, organized a Guest Lecture on "Mooting and Advocacy Skill" on 20th February, 2019. Mr. Ravin Kapur, currently working with *Pheonix Legal*, Delhi as an associate and Ms. Prerna Parashar, working with *Luthra & Luthra* Law firm graced the event with their presence as Chief Guests.

The session elaborated upon the importance of moot court competition as it's a simulation of a real court, with the basic purpose of giving the law students a taste of a real court room. Mooting helps a student of law navigate his path in the profession by giving him/her an idea about their field of interest. Various prestigious moot court competitions were also discussed in details and their significance, the guests also got a great response from the students who showed their eagerness to learn, and also shared their personal experiences of participation in mooting or debates or MUNs.

The Moot Court Sessions were held on 29<sup>th</sup> August and 30<sup>th</sup> August, 2019 in Seminar Hall, MAIMS. The purpose of the sessions was to impart the student with information pertaining to competitive moots and benefits of mooting in order develop their argumentative skills.

Another **Moot Court Session** was held by **Mr. Kadam Kharab** on **06 Sep, 2019** at Moot Court Hall in the Law Dept., MAIMS for the students of B.A.LL.B. (5th Semester). Mr. Kadam Kharab is a well-known trial lawyer practicing in District Court, Rohini, Delhi. The session highlighted the procedure followed in criminal courts including different stages of administration of criminal justice such as investigation, inquiry and trial. The session also included demonstration of trial court procedure based on a hypothetical criminal prosecution







An In-house Moot Court Competition (Inductions Rounds) was held in MAIMS, Department of Law on 27<sup>th</sup> and 28<sup>th</sup> September, 2019 in order to make the students aware about the proceedings, rules and regulations of a Moot Court, so that they can compete in National and International Moots with a greater ease.







# VI. WORKSHOP





The Guest Speaker, Ms. Monika conducted an interactive session with the students. She presented a



# IX. RECENT JUDICIAL VERDICTS

"Law and order exist for the purpose of establishing justice and when they fail in their purpose, they become the dangerously structured dams that block the flow of social progress" Martin Luther King Jr. These lines of Martin Luther King, the most visible spokesperson and leader of civil rights movement who always dreamt that the inhabitants of the USA would be judged by their personal qualities and not by the colour of the skin, clearly show that the path a judge has to follow should always and always be impartial and reasonable. The apex legal body of India, the Supreme Court delivers umpteen number of judgements and a few have been analyzed by our budding professionals.

# **4** A WOMAN CAN'T BE THROWN OUT OF MATRIMONIAL HOME EVEN IF IT DOESN'T BELONG TO HER HUSBAND

- ➤ On 15th October, 2020, Honorable Supreme court in Satish Chandra Ahuja v. Sneha Ahuja while interpreting Section 2(s) of the Protection of Women from Domestic Violence Act, 2005, which aims to ensure that in-laws treat their daughter-in-law well.
- ➤ The judgment delivered by Hon'ble Justice R Subash Reddy, Justice MR Shah and Justice Ashok Bhushan interpreted section 2(s) the Protection of Women from Domestic Violence Act as "the definition of shared household given in section 2(s) cannot be read to mean that household which is household of the joint family of which husband is a member or in which husband of the aggrieved person has a share".
- ➤ Hon'ble Apex Court widened the scope of the definition and held that a woman will have the right to the shared household even if it was rented or owned by in-laws or the husband has no ownership over the property. This judgment, therefore, protected the interest of women who have been or were at the risk of being thrown out of their marital home.
- ➤ Hon'ble Court interpreted that the meaning of living together and ruled out that there should be some kind of permanency attached to it. "Mere fleeting or casual living at different places shall not make a shared household. The intention of the parties and the nature of living, including the nature of the household, have to be looked into to find as to whether the parties intended to treat the premises as a shared household or not".
- ➤ The judgment was the need of the hour because the cases of Domestic Violence are very rampant in our Country, but they are not reported because a woman often resigns to her fate of domestic violence and the social stigma of the society.

#### **4** APEX COURT ON THE PROTESTOR'S RIGHTS AND DUTIES

- ➤ Hon'ble Supreme Court on 7th October, 2020 in Amit Sahni v Commissioner of Police decided upon the appeal filed by Mr. Amit Sahni, which was filed after the rejection of the writ petition in the High Court of Delhi. The writ was filed before the Hon'ble High Court on the issue Whether the protests that were carried out in Shaheen Bagh against CAA and NRC appropriate or not? since they blocked the passage and disallowed public movements.
- ➤ Hon'ble High Court in this matter directed & emphasized on the point that in such cases, a specific writ or order cannot be issued to the authorities i.e. the police because of the fact that situation under these circumstances changes frequently and they may require immediate powers to control the situation.
- ➤ Interlocutors Mr. Sanjay Hegde and Ms. Sadhana Ramachandran were appointed by the Hon'ble Supreme Court who went on ground zero in order to hear the grievances and demands of the protestors and prepared a report.
- ➤ Hon'ble Supreme Court pronounced on the rights available under Article 19(1)(a) [Right to freedom of speech and expression] and 19(1)(b) [Right to assemble peacefully without arms] of the Constitution of India and their scope and extent. It was stated that these rights are subject to some reasonable restrictions pertaining to the interests of sovereignty and integrity of India.
- > "Democracy and dissent go hand in hand but then the demonstrations expressing dissent have to be in designated places alone."
- ➤ Hon'ble Court also established a nexus between the use of technology and social movements wherein organising and publicity of the events everything can be done by way of internet and social media handles without missing out on the fact that technology works in empowering as well as weakening of such events and movements.
- ➤ Ultimately, Hon'ble Supreme Court was of the view that such protests and gatherings in the public places for indefinite period of time cannot be accepted and the administration must take appropriate actions to keep the areas clear of obstructions and encroachments.
- Luckily, due to the Covid-19 pandemic, the Shaheen Bagh was emptied and the protest was at a halt which saved everyone from unforeseen circumstances.
- ➤ This judgment hence polishes the scope and extent of Article- 19 that these rights are available to the citizens but with certain reasonable restrictions and one must abide to these in order to maintain public peace and harmony.

#### Reforms required to tackle Judicial Pendency in India

Speedy Justice is not only a fundamental right but also a prerequisite of maintaining the rule of law and delivering good governance. In its absence, judicial system ends up serving the interests of the corrupt and the law-breakers. According to the National Judicial Data Grid maintained by the Ministry of Law and Justice, there are about 3.5 crore cases pending in India, especially in district and subordinate court's (as they contribute 87.54 per cent of the total pendency).

In my view, for enhancing productivity in the judiciary, following reforms should be undertaken:

Increase in the number of working days; Establishment of Indian Courts and Tribunal Services to focus on the administrative aspects of the legal system; Deployment of technology to improve efficiency of the courts, e.g. e-Courts Mission Mode Project and the National Judicial Data Grid being rolled-out in phases by the Ministry of Law and Justice; Professional Court Managers as suggested by the 13th Finance Commission should be appointed; Mechanisms such as ADR (Alternate Dispute Resolution), Lok Adalats, Gram Nyayalayas should be effectively utilized.

India currently has 1/5th of the number of judges it needs. Therefore, in order to clear this backlog it is very essential to ensure the expeditious appointment of judges on a priority basis. Judicial Reforms, if taken seriously, expeditious and effective justice can see the light of the day and improve India's judicial pendency and serve justice to the poor litigants and those languishing in the jails.
