MESSAGE FROM THE NEWSLETTER TEAM:




ACTIVITIES OF THE DEPARTMENT JANUARY – MARCH 2021




Dr. Praveen Kr. Gupta, Head, Department of Law, MAIMS gave a vote of thanks to everyone for making the conference a success.

THE FIRST JUSTICE J.S. VERMA MEMORIAL ADR AND CLIENT COUNSELLING COMPETITION AND THE LAW FEST (NAVITAS) OF THE DEPARTMENT OF LAW, MAIMS.

Department of Law, Maharaja Agrasen Institute of Management Studies, organized its 1st Justice J. S. Verma Memorial ADR & Client Counselling Competition from 17th to 19th March 2021, along with the 1st National Law Fest - *NAVITAS*, from 20th to 21st March, 2021.



This event was held in collaboration with National Legal Services Authority (NALSA), a nodal agency working rigorously to promote alternative dispute resolution in India. Other collaborators were Foundation for Sustainable Rule of Law Initiatives (FSRI), a reputed international organisation based in California, USA which encourages sustainable initiatives for conflict resolution outside courts, and CAMP Arbitration and Mediation Practice (CAMP), based in Bangalore that promotes dispute prevention and collaborative dispute resolution through education and advisory services.







The event unfolded under the guidance of our Principal Prof.(Dr.) Rajni Malhotra Dhingra ,and faculty members—Dr. Nisha Dhanraj Dewani and Ms. Kriti Johri. Special mention may be made of our Faculty member Dr. V.K. Bhatnagar who was instrumental in organising the Inaugural event. Among the students, Ms. Palak Tyagi, Ms. Ritika Bansal, Ms. Grishita Chopra, Mr. Shivam Sethi, Mr. Ayushman Patnaik, Mr. Harsh Maheshwari, Ms. Deeksha Chugh, Ms. Disha Moitra and Ms. Haritima Singh formed the core committee and played an important role in the execution of this 5-day event.

MODE OF COMPETITIONS

Owing to the COVID-19 pandemic, the entire event was held in the virtual mode. Competitions such as Mediation, Client Counselling, and Asian Parliamentary Debate were held via Zoom, whereas Negotiation, Extempore Moot Court, and Just-a-Minute were held via Google Meet. The Constitutional Law Quiz was conducted via Google Forms. In competitions such as Article Writing, Creative Writing, Judgement Writing, Best out of Waste, Solo Singing, Traditional Dance, Stand-up Comedy and Poster Making, submissions from participants were requested beforehand via email.





DAY 1: INAUGURAL CEREMONY, 17th March 2021

The Inauguration Ceremony of MAIMS 1st Justice J.S. Verma Memorial ADR & Client Counselling Competition 2021 and *NAVITAS*, MAIMS 1st National Law Fest 2021was held on 17th March, 2021, in physical mode at India International Centre, New Delhi and was also live streamed on YouTube. The competition which will be held annually in memory of Justice J.S. Verma has the blessings of his daughters Shubhra and Dr. Rashmi. The event began by seeking the eternal blessings of Goddess Saraswati and lighting of the lamp. The welcome address to the audience was given by Prof. (Dr.) S.K. Garg, Director General, MAIMS who emphasized on ADR being a good option to resolve disputes as "Justice delayed is justice denied". The audience received a special Address by Dr. Nand Kishore Garg, Founder Chairman & Chief Advisor, MATES, and Chancellor- MAU (H.P.).











He laid emphasis upon how inappropriate the word 'Alternate' is for the Alternate Dispute Resolution System. Discussing the vital role played by judges he advocated that the Supreme Court Judges should never retire which would help in a speedy disposal of cases based on their experience.

It was indeed a privilege to have Hon'ble Mr. Justice A M Khanwilkar, Judge Supreme Court of India as the Guest of Honour for the inaugural ceremony. He talked about the journey of Hon'ble Justice J.S. Verma as a man of strong will power and ethics. He gave the audiences an insight into several landmark judgments of which Justice J.S. Verma formed a significant part. Eventually, he discussed the importance of understanding the basics of an alternate dispute resolution system and the value it holds in a society.

The Chief Guest of the event, Hon'ble Mr. Justice N.V. Ramana, Judge, Supreme Court of India & Executive Chairman- NALSA and now the Hon'ble Chief Justice of India since 24th April 2021, enlightened the audience by talking about the wide range of cases dealing with numerous laws which were dealt by Hon'ble Justice J.S. Verma. He described Justice J.S. Verma as a man who believed in hard work and determination. Sharing insights into the works done by Hon'ble Justice J.S Verma even after his retirement, he felt proud to be a part of the Indian Judiciary. He also suggested an action plan to reduce the backlog of nearly three crore pending cases. He also suggested about setting up more courts, use of e-platform and settling of disputes at prelitigation level. He also strongly favoured the efficient and active working of the Lok- Adalats.

The event was also marked by the release of the book titled "Specific Contracts", authored by Prof. (Dr.) Rajni Malhotra Dhingra, Principal, Department of Law, MAIMS. The book will prove definitely useful for higher legal studies.

The event concluded by a vote of thanks by Prof. (Dr.) Rajni Malhotra Dhingra, Principal, Department of Law followed by the National Anthem.

<u>DAY 2: ADRCC & PARLIAMENTARY DEBATE</u> PRELIMINARY ROUNDS & QUARTER FINALS (18th March, 2021)

The preliminary rounds of Negotiation, Mediation, Client Counselling and Asian Parliamentary Debate. began at 9:00 a.m. sharp. The 'Confidential Information' for Negotiation and Mediation was released to the participants via email, 60 minutes and 30 minutes prior to the beginning of the preliminary rounds, respectively. The 'Confidential Information' is essentially a piece of information that is holding back either of the parties to the transaction from performing their part of the obligation/promise.

For Client Counselling, only one Preliminary Round was held. The Client Counselling Team had prepared 11 students from the Department of Law to pose as 'clients', who would be 'counselled' during the proceedings.

For Asian Parliamentary Debate, three Preliminary Rounds were conducted The Quarter Final round and the Semi-Final Round for Parliamentary Debate was held the same day at 7:30 p.m.

DAY 3: ADRCC & PARLIAMENTARY DEBATE SEMI FINALS & FINALS

The Semi-Final round of Negotiation Competition had four teams - Himachal Pradesh National Law University, Shimla; Two teams of Jindal Global Law School, Sonepat and Vivekananda Institute of Professional Studies., Delhi. VALUE ADDED COURSE:

Another feather added in the achievements of the Department of Law is the Value added Course which it has started for the students. The course idivided in seven modules started from 25th of February and is scheduled to wind up on Friday, 16th April 2021. It is a very good initiative by the Department to provide the facility of some extra teaching by experts in their respective fields to our students. The present value added course aims at legal drafting which is divided into headings like the Drafting of Criminal Proceedings; Drafting of Civil Pleadings; Contract and Rent Matters; Constitution; Deeds and Wills; Important Petitions and arbitration. Our students are lucky to have the honour to get lectures from expert academicians. The expert lectures were conducted by Academicians and Legal Practitioners of repute.

The inaugural session took place on 25th February.

First session was conducted by **Prof.** (**Dr.**) **B.T.Kaul**, who is an Academician, a Legal expert, practicing advocate and has been the Chairperson of the Delhi Judicial Academy. He gave lecture on the topic ,"**First Information Report** (**F.I.R.**) and the Quashing of **F.I.R.**" Kaul sir elaborated thoroughly by touching landmark judgements and drew a comparison between the personal liberty and the fundamental rights.

Second session was held on 26th February 2021 and was conducted by **Mr. P. K. Dubey** who is a practicing lawyer with specialisation in anti corruption cases, white collar crimes, and offences involving FEMA and MACOCA. He spoke on "Bail Application, Anticipatory Bail Application, and Complaint for the Dishonour of Cheque."

Third session on 6^{th} March was conducted by **Ms. Monika Srivastava**, an expert in matrimonial and Customer Protection and Matrimonial disputes. She spoke on the topic "**Drafting of Civil Proceedings**"

Fourth session took place on 7th March 2021 when the chief speaker, Mr. Anupam Srivastava who is a practicing Lawyer spoke on "Civil Suit for Recovery, Summary Suit, Appeal, Review and Revision Petition".



Prof. (**Dr.**) **Ritu Gupta** conducted the fifth lecture of Value Added Course on 12th March. She teaches at the prestigious National Law University, Delhi and she spoke in the topic "**Drafting a Limited Liability Partnership Contract.**"

Sixth lecture was conducted on 13th March by **Prof.** (**Dr.**) **Kanwal D.P. Singh** who teaches at the USLLS, GGSIPU, Delhi. She presented on the topic "Suit For Specific Performance & Recovery of Damages in case of Breach of Contract, and Petition For Eviction of Tenant"

The Seventh session was conducted on 25th March 2021 on the topic "**Drafting of Writs and Special Leave Petition**" and was conducted by Prof.(Dr.) S.N.Singh who is considered the longest serving Professor of Law in the Faculty of Law, University of Delhi.

The eighth session was conducted on 26th March 2021 by renowned advocate and social activist **Mr. Ashok Agrawal** who enlightened the students on the topic "Drafting **of Public Interest Litigation**" With the help of case laws he explained to the students about meaning, ingredients and contents of the PIL. The sessions of this value added course will continue till the month of April. Legal drafting is a basic skill which each legal professional should know. Whether he or she is taking up teaching, judiciary or simple practicing, this skill has to be attained. Through a series of these lectures, our students have benefitted very much and have been acquainted with the minute details of drafting.

Such value added courses are now a regular phenomenon and will keep on happening in the department under the able guidance of our Principal Prof. (Dr.) Rajni Malhotra Dhingra.

STUDENT'S CORNER

AIJC- A New Journey of Judgeship

Union Law Minister Ravi Shankar Prasad said during the recently concluded Rajya Sabha session that a "properly framed" All India Judicial Service (AIJS) on the lines of other all-India systems such as IAS and IPS is needed to boost the overall justice delivery mechanism.

In a written response, he stated that the service would allow for the recruitment of suitably skilled fresh legal talent selected through a proper all-India merit selection system, as well as address the issue of social inclusion by providing appropriate representation to marginalise and impoverished sections of society

The hon'ble union law minister's comment has sparked a debate in India's judicial corridors. The case for an All-India Judicial Service has been made on many occasions. The Chief Justices' Conference of 1961, 1963, and 1965 proposed an All India Judicial Service as a way to exclude any judicial or executive interference in the appointments to the judiciary in India's High Courts and Supreme Court.

After several states and High Courts objected, the plan had to be shelved. Even the 14th Law Commission report on 'Judicial Reforms' recommended the AIJC for the sake of a more effective judiciary. The 1ST National Judicial Pay Board, National Advisory Council, and Parliamentary Standing Committee have all recommended it.

Article 312 of the Constitution was revised in 1976 to include an AIJS. The plan was floated again by the ruling UPA government in 2012, but the draught bill was shelved after High Court Chief Justices objected, calling it an infringement of their rights.

Advantages of All India Judicial Service includes the following points -:

- 1. It would increase the efficiency of judicial officers in high courts, with one-third of judges rising through the ranks from lower courts.
- 2. The Supreme Court's judges are chosen from the lower courts. The people ultimately chosen for the judiciary will have shown integrity through this process.

- 3. Given that the strength of the judiciary in subordinate courts is less than a fifth of the total number of approved positions, such a move is likely to help ease pendency.
- 4. From the lowest to the highest levels of the legal system, the standard of adjudication and the administration of justice will experience radical changes.
- 5. Only judges with established integrity will preside over the benches, limiting the scope of judicial asymmetry, arbitrariness, and nepotism.
- 6. Using the Union Public Service Commission to recruit will guarantee the highest level of objectivity and accountability in the hiring process.
- 7. India might follow the French model of a career judicial service, which would put an end to the current turf war between the judiciary and the executive over judicial appointments.
- 8. The creation of an All India Judicial Service will improve the judiciary's accountability, professionalism, and fairness.

Disadvantages Of All India Judicial Service includes the following points -:

- 1. A lack of understanding of regional languages will have a negative impact on judicial performance.
- 2. The key question posed by the states is that they have used their powers under the CrPC and Criminal Procedure Code (CPC) to declare that a local language can be used except for writing orders in lower courts.
- 3. Anyone who had previously worked for the government would have less chances for advancement.
- 4. The high courts' power over the subordinate judiciary would erode, impacting the judiciary's independence.
- 5. Another point of contention is that an all-India judicial service would obstruct the promotion of state judicial service officers.

Conclusion-

The subordinate judiciary is now fully dependent on state recruitment. The brighter law students, on the other hand, do not join the state judicial services because they are unappealing. Furthermore, there have been complaints of lack of accountability in lower-level judiciary recruitment by state public service commissions. No one with a reputable Bar practice wants to become an additional diarist because there is no way to advance their career.








FACULTY'S ACHIEVEMENT
