The speaker for the first session was **Sh. Kanwal Jeet Arora.** Sir is currently the Member Secretary of Delhi State Legal Services Authority. Sir took the session on "Introduction to Legal Services Authorities Act, 1987, its activities as well as the Role and responsibilities of Para legal Volunteers." It was an introductory session to make the students aware of the concept of Para Legal Volunteers.

It was followed by a vote of thanks speech delivered by Prof. (Dr.) Rajni Malhotra Dhingra, Principal, Department of Law, MAIMS.

The speaker for the second session was **Ms. Namrita Aggarwal**, Additional District and Sessions Judge. Ma'am took the session on "Basic structure of Constitution with special emphasis on fundamental rights and Fundamental Duties." Ma'am explained how the constitution provides for free access to legal services and guards the rights of all citizens. Third session was taken by **Mr. Harjeet Singh Jaspal**, Secretary, North DLSA. The topic for the session was "Matrimonial Laws" where sir emphasized on various the matrimonial laws, remedies available to victims, etc and how DLSA or para legal volunteers deal with such issues. The speaker for the last session of the day was **Sh. Rajesh Kumar**, Director, SPYM. Sir took the session on "Drug Abuse amongst children – Indications and Rehabilitations of Children in need of care and protection".

DAY-2 (7th December)
