### **“LEGAL AID FOR THE POOR DOES NOT MEAN POOR LEGAL AID”, SAID BY HON’BLE MR. JUSTICE U.U. LALIT IN A LAW FEST ORGANIZED BY DEPARTMENT OF LAW, MAIMS**

Department of Law, Maharaja Agrasen Institute of Management Studies, Delhi organized the Inaugural Ceremony of the “MAIMS 2<sup>nd</sup> Justice J S Verma Memorial ADR & Client Counselling Competition, 2022” and NAVITAS MAIMS 2<sup>nd</sup> National Law Fest, 2022 in association with NALSA on Wednesday, 23<sup>rd</sup> March 2022, at NDMC Convention Centre, New Delhi. It was a five-day mega event which culminated on 27<sup>th</sup> March 2022.

The occasion was graced with the august presence of Hon’ble Mr. Justice U.U. Lalit, Judge, Supreme Court of India & Executive Chairman, NALSA, Hon’ble Mr. Justice A.M.
