II. THE SIGNING OF MOU BETWEEN THE DEPARTMENT OF LAW, MAIMS AND THE B.R. AMBEDKAR LAW UNIVERSITY, SONEPAT,11TH NOVEMBER 2021

11th November, 2021 was a red letter day in the history of Maharaja Agrasen Institute of Management Studies when a Memorandum of Understanding was signed between the two institutions. 


IV. <u>THE BRIDGE COURSE, 11 OCTOBER 2021 TO 16</u> OCTOBER 2021

The new session for the newly admitted students of BALLB and BBALLB started with the Bridge Course. The Bridge course is designed to prepare a student for advanced education. It was aimed to provide a sort of bridge passing through which a student of Class XIIth could move to the much advanced and professional arena of legal education. Students basically come from the streams of Arts, Science or Commerce. Usually it is found that students who do not study a certain subject as senior secondary level face many challenges while studying it at graduation level. Thus this Bridge course aimed to prepare them to understand the nuances of legal education and at the same time to understand about the disciplines of History, Sociology and Legal English and Economics.



This was a maiden initiative of the Department of Law, MAIMS. Course was planned for History, Sociology, Economics, Political Science, and Legal English from 11th October 2021 to 16th October 2021. The Resource persons for the course were Dr. V.K.Bhatnagar (Political Science); Dr. Anuradha Asthana Singh (History); Dr Nirdosh Kumar(Sociology); Ms. Ritika Bhatia (Economics) and Ms. Soumya Sharma (Legal English)

Besides this a session of SCC online was conducted in an online mode on 16th October 2021 by Mr. Chetan Singh Gill, a Master Trainer and Sr. Manager



(Training) at SCC Online.

At the end of the session a MCQ test of the students was conducted in online mode. It was a 24 hours course with 20 hours of delivery of course curriculum, 2 hours of SCC session and 2 hours of course end exam.

The entire course was planned and executed by Dr. Nirdosh Kumar, Faculty, Department of Law.

VI. <u>GUEST LECTURE ON "Analysis Of Preliminary And</u> <u>Final Decree vis-à-vis Ayodhya Judgement", 13TH November,</u> <u>2021</u>



The Department of Law organised a Guest lecture on the topic – "Analysis of Preliminary and Final Decree vis a vis Ayodhya Judgment" on 13th November 2021 in a virtual mode.

Anant Vijay Maria who is an Advocate practicing in the Supreme Court of India.

He explained all the aspects of the Ayodhya Dispute which started in the year 1857, with a suit being filed for the first time concerning the matter of worship. With the demolition of Babri Mosque in 1992 communal differences arose among Hindus and Muslims and also gave birth to the most famous Ayodhya Case or Ramjanmabhumi Case involving a property dispute of the land measuring 2.77 acres. Sir touched on various aspects of the case without touching on the religious part involved with the case. He explained the preliminary decree passed by the Allahabad High Court dividing the land equally among the Hindus, Sunni Waqf Board and the Nirmohi Akhara. Further when the case went into appeal to the Apex Court, the Constitutional Bench comprising of five judges unanimously decided to allot the whole land to the Hindus and the Central Government to be given a time of three months to set up a trust or the construction of the temple and a separate five acres land to be allotted to the Sunni Waqf Board for the construction of the mosque. The session was of great help to all the students as the Speaker clearly explained all aspects of the case in a simple and lucid manner. The session was conducted by the faculty coordinator, Dr. Nisha Dhanraj Dewani, Associate Professor, Department of Law, MAIMS.

VII.<u>WEBINAR ON "Acid Attack: Uncivilized and Heartless</u> <u>Crime" (In Collaboration with National Commission for</u> <u>Women, Delhi)</u>

Department of Law and the Gender Sensitization and Equality Initiative Club, Maharaja Agrasen Institute of Management Studies organized a One Day Webinar on " Acid Attack: Uncivilized and Heartless Crime" on 23rd November 2021. This program was organized in association with the National Commission for Women.



Prof.(Dr.) S.K. Garg, Director General MAIMS, in his welcome address highlighted the importance of women in the society and the problems which they have to face on a day to day basis.

Prof. (Dr.) Ravi Kumar Gupta, Director MAIMS, in his address appreciated the efforts of the women power in shaping the society and highlighted the incidences of rising crimes against women in the society.

honor women and girls.

There were five technical sessions where the experts in their respective fields presented their views on the issue and enlightened the audience.

The experts were: Ms. Abha Malhotra, Sr. Counsel, Supreme Court of India; Prof.(Dr.) Debarati Halder, Professor, Parul University, Ahmedabad; Ms. Shaheen Malik, an acid attack survivor & Founder Brave Soul Foundation; Dr. Siddhartha Mishra, Sr. Assistant Professor, Faculty of Law, University of Delhi and Dr. Anjana Malhotra, Associate Professor, Shanti Devi Arya Mahila College., Dinanagar.



They covered diverse topics like Legal Implication of Acid Victim, Implementation of Victim Compensation scheme, Role of NGOs in combating Acid Attack violence, Health Care Management of Acid Attack Victims and Factors of Acid Violence in India.


Each session was followed by a very interactive Question Answer session. The Convener of the event was Dr. Shaveta Gagneja.

VIII.THEMOOTCOURTCOMPETITION&CONSTITUTIONDAYCELEBRATIONS,2626NOVEMBER, 2121TO28THNOVEMBER 2021

The second National Moot Competition was organized by the Department of Law, MAIMS from 26th to 28th November 2021. The competition was organized in a hybrid mode.

The Inaugural session took place on 26th November in the MATES auditorium and along with this was celebrated the "National Constitution Day". The event was graced by the presence of the Chief Guest Hon'ble Mr.Justice Jayant Nath (Retd Justice, Delhi High Court) .It was a privilege to have Mr. Sudhanshu Batra, Senior Advocate, Supreme Court of India , and Dr. K.D. Singh, Director (Law) and Central Public Information Officer of the Competition Commission of India , as the Guests of Honor of the event. The torch bearer of MATES, Dr.Nand Kishore Garg who is also the Founder Chair and Chief Advisor MATES and Chancellor, MAU, Baddi also graced this momentous occasion. Four teams including the Symbiosis International University, Pune; SVKM Pravin Gandhi College of Law, Mumbai; Singhad Law College, Pune; and Jagran Lake City University, Bhopal were the semi-finalists.

The Final Round took place between the Singhad Law College and Symbiosis Law University, both from Pune. The team of Finalists argued with enunciation and clear expression for each perspective.

The Final round was adjudged by a bench of three judges consisting of Hon'ble Ms. Justice Deepa Sharma, Former Judge, High Court of Delhi; Ms. Aishwarya Bhati, Senior Advocate, Supreme Court of India and Ms. Tanu Bedi, Senior Advocate, Punjab and Haryana High Court, Chandigarh.

The Valedictory Ceremony was conducted virtually in the evening of 28th November, 2021with the presence of Honorable Mr. Justice C.Harishankar, Judge, Delhi High Court as the Chief Guest. 6th – 8th December 2021

To provide free and easy legal aid to the surrounding areas has been an important aim of the Department of Law since its very inception. The Legal Services Clinic has been very active in providing such help and organizes training sessions from time to time in association with the DLSA.

The inaugural session was graced by the presence of Hon'ble Mr. Kanwaljeet Arora, Member Secretary, DLSA; Ms. Namita Aggarwal, Additional Secretary, DLSA; Mr. Abhishek Kumar, Secretary Northwest DLSA ; Mr. Rajesh Kumar, Executive Director, SPYM.

The session also witnessed the august presence of Dr. Nand Kishore Garg, Founder Chairman & Chief Advisor MATES ; Prof. (Dr.) S.K.Garg, Director General MAIMS; Prof.(Dr.) Ravi Kumar Gupta, Director MAIMS ; Prof. (Dr.) Rajni Malhotra Dhingra, Principal, Department of Law, MAIMS; Dr. Praveen Kumar Gupta, Head, Department of Law and other Faculty members.

Mr. Kanwaljeet Arora spoke on the topic "Introduction to Legal Services Authority Act 1987": Its Activities as well as Role and Responsibilities of Para Legal Volunteers"

The speaker for the second session was Ms. Namita Aggrawal who spoke on the topic "Basic Structure of Constitution With Special Emphasis on Fundamental Rights and Fundamental Duties". She explained how the Constitution provides for free access to Legal services and guards the rights of all citizens.

The third session on the first day was conducted by **Mr. Harjeet Singh Jaspal**, Secretary North DLSA and he spoke on the topic "**Matrimonial Laws**".

The last session of the day was conducted by **Mr. Rajesh Kumar**,Director, SPYM and he spoke on "**Drug Abuse amongst Children----Indications and Rehabilitations of Children in Need of Care and Protection.**

The second day, 7th December witnessed lectures by three speakers Mr. Abhishek Kumar, Secretary North West DLSA, Ms. Aakanksha Vyas, Secretary, South East DLSA; Ms. Nabeela Wali, Secretary, South DLSA and Mr. Vikas Chandwani, Soft Skills Trainer. They spoke respectively on the topics—Laws on Children with Special Emphasis on Cyber Crimes and Delhi Victim Compensation Scheme; Various Laws relating to Women; Overview of Criminal Justice System and Schemes of DLSA and Effective Communication and InterPersonal Skills.



The students of the Department of Law also presented a cultural performance.

The third day, 8th December started with the performance of BALLB first year student, Nishant Kumar.

The first speaker, Mr, Ashish Kumar, Secretary, Shahadara, DLSA enlightened the students about the purpose and the growing importance and usefulness of Right to Information Act to the society as a whole.

Ms. Neha Priya, Secretary, South West DLSA spoke on the topic "Laws Relating to Senior Citizens and Transgenders"

The speaker of the third and final session was Mr. Himanshu Sehlot, Secretary, Central II, Rouse Avenue Courts who discussed numerous state and central Labour Laws in brief and the Importance of Labour Codes.

All the sessions throughout the three days programme were highly informative and vital for the budding Para Legal Volunteers. The students actively participated and all the sessions witnessed interesting Question Answer rounds at the end of each session.

The entire PLV session was coordinated by Ms. Purnima Gupta, Legal Aid Officer, Department of Law, MAIMS. Ms. Akanksha Gupta, Faculty, Department of Law assisted in the program.

X. VALUE ADDED COURSE

We enter into Contract daily but seldom realize their importance. Contractual relations represent a commitment and ensure that what has been promised, it must be performed.

Clarity in the terms stipulated in any Contract is pivotal as it showcases the intention of the parties while they ushered into a stage of consensus-ad-idem. Electronic Contracts have fostered this legal relationship even further. This Value added course is designed to help the students to comprehend the solution of the complex issues in the distinguished branch of the Law of Contracts.

The course started in December 2021 and will conclude in May 2022.

The first session took place on 15th December 2021 and the speaker was Mr. Anand Kumar Mishra who is currently posted in the Advocacy Division of the Competition Commission of India as Joint Director. The topic for the session was Principles Governing A Tender and its Alignment with the Contract Law, which was elaborated thoroughly by discussing the landmark judgments relating to CCI and drawing the comparison between the invitation to the offer and the offer with the help of section 2 (1) of the Indian Contract Act 1872, and the provisions of Competition Commission Act 2002. He expounded the difference between the agreement in the Indian Contract Act, 1872 and the agreement in the Competition Commission Act 2002, and ended the discussion by giving all the pertinent information about the topic.



The second session was held on 16th December **Dr. Anant Vijav** Anant Dr. has Maria. completed his Legum Baccalaureus from the Delhi University and LLM from NLU, Delhi. He is a Lawyer in the Hon'ble Supreme Court of India and is practicing in the various commercial tribunals and High courts of the country as well. The topic for the session was


"Enforcement of Commercial Contractual Rights & Obligations through the Writ Jurisdiction". He took the stage by asking some basic questions from the luminous students and then elaborated it deeply by touching the real-life company's example and the recent high-profile cases. He coached students the difference between the remedy as arbitration and the Writ petition for the breach of the Contract with the assistance of section 79, 80, 81 of the CPC and article 229 of the Constitution.

The third session took place on 22nd December 2021 and the Resource Person was Mr. Vinay Pandey. He is a main stream litigation lawyer who practices primarily on the civil original side, before the honorable High Court of Delhi. Mr. Pandey has represented government entities viz Delhi Development Authority, Mahanagar Telephone Nigam Limited; and Central Warehousing



Corporation. The topic of his lecture was Quasi Contract – A Sobriquet to Valid, Binding & Enforceable Contracts. Starting with the basic introduction of law of Contract with essentials of formation of a valid contract, he differentiated between an agreement and a contract. He also explained the

concept of Quasi Contract and gave a detailed information about Sections 68, 69, 70, 71 and 72 of Indian Contract Act, 1872 which deals with Quasi Contract.



The fourth session took place on 23rd December and the resource person was Mr. Tarun Gaur. He is an Advocate practicing in areas of Anticipatory Bail, Arbitration, Bankruptcy / Insolvency, Breach of Contract, Civil, Corporate, Criminal, Cyber Crime, Media and Entertainment. The topic for the session was "Default Remedies For Mitigating the Damages Resulted to the Disappointee Promisee" He started the session with the basics of contracts and different types of contracts. He also discussed the

importance of networking in law field and explained that every default remedies available in the aforesaid topic with landmark case laws. He explained elaborately about the following remedies: specific performance, injunction, and compensation for loss or damage. Moreover, he stressed upon the section 74, 75, 221 and 231 of the Indian contract Act, 1872.
