II. VIVEKANANDA JAYANTI CELEBRATIONS, 12 JANUARY 2022 (As part of "Azaadi Ka Amrit Mahotsav" Celebrations)

Maharaja Agrasen Institute Of Management Studies in association with Maharaja Agrasen Institute of Technology, Rohini, Delhi organised Swami Vivekananda Jayanti Celebration on the occasion of birth anniversary of Swami Ji on 12th January 2022. This celebration was part of the ongoing "*Amrit Mahotsav*" celebrations. The event was organised virtually on the Zoom platform and was attended by more than 450 participants.

The program started at 12 noon with the invocation of goddess Saraswati followed by the remarks of Prof. (Dr.) Ravi Kumar Gupta, Director MAIMS who gave a brief introduction of the educational institutions which are functioning under the umbrella of Maharaja Agrasen Technical Education Society. He also appreciated the great vision of the Founding Chairman & Chief Advisor MATES as being a strong pillar of bringing social reforms as well as to provide quality technical education.

Prof.(Dr.) S.K Garg ,Director General MAIMS, in his welcome address threw light on National Youth Day, which is celebrated on 12th January, since 1985. He made a point that though Swami Vivekanand lived a short life, yet it was a highly fruitful life from the point of view of the youth of a dependent country. He left a great impact on socio-cultural tradition. He concluded his speech with the words of Swami Vivekanand "you become what you think of" The Chief Guest of the occasion was Prof. (Dr.) Ashok Vohra who has retired from Delhi University as Head of the Department of Philosophy and Dean, Faculty of Arts. A regular columnist in national dailies like "The Times of India", "The Hindustan Times", "The Tribune" etc., having deep knowledge of the teachings of Swami Vivekananda and he explained it in a simple and interesting manner to the students. Professor Vohra described Swami Vivekananda as a man who enlightened citizens to know their rights and duties and was a firm believer in building society by education. Furthermore, he added by saying inclusion is important and we must include love and serve others. He also said that selfishness can be only cured by the right type of education. Moreover, he emphasised that our Constitution has provision for fundamental duties also along with rights and this was the vision of Vivekanand, many years back i.e. to make the youth aware of their duty and responsibility. He wanted to instill in the youth a sense of responsibility towards their country and towards the poor and the downtrodden. By mentioning about the Article 51 (A) of the Constitution, Prof. Vohra said that this article abides every citizen of India to respect its ideals, institutions, national flags and the national anthem.

In his special address, Dr. Nand Kishore Garg, the Founder Chairman and Chief Advisor MATES and Honourable Chancellor, Maharaja Agrasen University, Baddi, emphasised on two ideologies of Swami Vivekananda , SPIRITUALISM & NATIONALISM. He also reminded us of the fact that Swami Vivekananda was not only a famous personality in India but in AMERICA too as his groundbreaking speech is an inspiration for all. He also worked on social evils like untouchability and child marriage. He concluded, by again laying emphasis on the spirit of nationalism and the power of INDIAN YOUTH.

At the end of the program vote of thanks was presented by Prof. (Dr.) Neelam Sharma, Director of Maharaja Agrasen Institute of Technology. She encouraged the students to follow the path shown by Swami Vivekananda as this only would lead them to the path of progress and prosperity. IV. INTRA MOCK TRIAL, 10th February, 2022

The Department of Law, Maharaja Agrasen Institute of Management Studies conducted its Intra Mock Trial Competition on 10th February 2022 virtually. The competition was essentially a simulation of the court proceedings that unfolded during a criminal trial including intricate aspects such as witness examination and presentation of final arguments.

A total of 11 teams participated in the competition along with a dummy team to achieve an even number of participating teams. Each team consisted of a maximum of three members which was generally a combination of two speakers and a researcher. The competition was adjudged by eminent practicing advocates and academicians having rich experience and expertise in criminal law.

The competition began at 9:00 AM with witness allotment which was followed by Saraswati Vandana. After half an hour of witness allotment the teams were guided to log in to their respective courtrooms and proceed with the commencement of the trial. The preliminary rounds started at 10:15 AM and concluded at 11:15 AM. The highest scoring winning teams qualified to the final rounds of the competition. The final round of the competition was adjudged by Advocate Vikram Seth and Advocate Saran Manocha.

Post completion of the rounds, the results were announced by the Principal, Department of Law. Prof. (Dr.) Rajni Malhotra Dhingra. The team consisting of Ms. Priyanshi Rai, Mr. Gauri Rajhans and Ms. Riya Bansal were declared as the winners of the competition. The team consisting of Mr.Shubham Paul, Mr. Prince Verma and Ms. Misha were declared as the Runners up team. Mr. Shubham Singh was adjudged as the Best Speaker and Mr. Sanyam Jain was declared to be the best witness. The award of Best Memorial was bestowed upon the team consisting of Ms. Anshita Khandelwal and Mr. Sarthak Budhiraja.

The competition was a rewarding experience for the students as it gave a close insight into the working of the court rooms and conduct in criminal trial. It helped in enhancing the oratory and research skill of the students which is an asset for any budding lawyer.

The Inaugural Session:

The much awaited Law Fest of the Department and the opening ceremony of 2nd Justice JS Verma Client Counseling and ADR Competition, in association with NALSA, took place on 23rd March 2022 at the NDMC Convention Centre, New Delhi. The event was held in collaboration with National Legal Services Authority (NALSA), a nodal agency working rigorously to promote alternative dispute resolution in India. The evening was blessed with the illuminating presence of Honorable Justice U.U.Lalit, Judge, Supreme Court Of India & Executive Chairman NALSA and Honorable Justice A.M. Khanwilkar, Judge Supreme Court of India, Honorable Justice, Mr. Sudhir Kumar Jain, Judge High Court of Delhi, and Dr. Nand Kishore Garg, Founder Chairman & Chief Advisor, MATES and Honorable Chancellor, Maharaja Agrasen University Baddi (H.P.). Mrs. Shubhra, daughter of Late Justice J.S.Verma, Mr. Mohan Garg, Jt. General Secretary, MATES, Mr. Rajnish Gupta, , MATES, Prof. (Dr.) S.K.Garg, DG, MAIMS; Prof. (Dr.) Ravi Kumar Gupta, Director MAIMS and Prof. (Dr.) Rajni Malhotra Dhingra, Principal, Department of Law ,MAIMS were present among other dignitaries.

The program started with the invocation of Goddess Saraswati and felicitation of the guests. An impressive performance was given by the students on the sacrifice of the "*Azaadi ke Deewane*" Bhagat Singh, Sukhdev and Rajguru as that day coincided with the "*Shahidi Diwas*".

First was to remember Justice Verma who would always act as the torch bearer and the guiding spirit for all legal professionals as well as students. "His works in the field of environment were really commendable in the present circumstances", Justice Lalit said. The second reason of his coming was as the Chairperson of NALSA whose main aim was to resolve the dispute in an alternate manner. As the Chairperson of NALSA it was his esteemed duty to popularize ADR. Thirdly he said that the Law Student should work as the legal advisors of the lay person. They should make the common man understand the legal system as well as provide free legal aid to the needy. Justice Lalit emphasized that it was his aim to catch and train the students about their responsibility as legal service provider for the needy and the poor. At the end of the function, Prof.(Dr.) S.K.Garg presented the vote of thanks. The program ended with the "National Anthem".

He started with giving introduction about What is Oral/Verbal contract? He also gave us a detailed information of Section 10 of Law of Contract, conditions like Section 10 does not prohibit Oral/ Verbal Agreements. He also explained Section 92 of Evidence Act i.e. No oral Testimony and brief about Commercial Transactions. At last, he gave example of oral agreement and ended the discussion by giving all the information about the topic and by clearingall the doubts of students.

VII. ARTICLES BY STUDENTS:

1. Arbitrability of the Tenant -Landlord Disputes

Our country's arbitration law has undergone quick modifications, with the majority of these changes owing to the pressing necessity for India to become arbitration hub in the international economic and business arena. Several other developments in the subject of arbitration law have primarily been made to achieve the goal of ADR, which is to resolve disputes quickly and efficiently. The goal of both the legislature and the judiciary has been to limit the role of the courts in the arbitration process and to give finality to arbitral rulings, resulting in increased trust and confidence among litigants in the ADR system. The current case is yet another important step forward for the judiciary in this direction. Before proceeding with a dissection and complete analysis, it is necessary to first identify the numerous matters that the Apex Court has adjudicated and decided upon in the judgement under consideration, which are as follows:

The first is "non-arbitrability of a subject matter," and the second is "who would be the competent authority to decide non-arbitrability, the Court at the reference stage or the Arbitral Tribunal itself?" When a reference was made to the Apex Court for determining the validity of an earlier decision of the Apex Court in *Himangni Enterprises v. Kamaljeet Singh Ahluwalia*, where it was held that landlord-tenant disputes governed by the provisions of the Transfer of Property Act, 1882 are not arbitrable because it would be contrary to public policy.

The arbitrator lacked jurisdiction to determine whether the landlord was entitled to seek possession based on a broader evaluation of public policy, it was determined. As a result, it was agreed that the matter would be decided solely by the Court of Small Causes, which was the only court with jurisdiction. Furthermore, in the case of *Booz Allen*, it was determined that in circumstances of eviction or tenancy matters governed by special statutes, when the tenant is afforded statutory protection, only the court designated by the act has jurisdiction.

The Court in *Himangni Enterprises* relied on the preceding ratios to hold that, while the Delhi Rent Act was not applicable in the aforementioned case, that did not imply that the Arbitration

Act would be applicable to give the arbitrator jurisdiction. As a result, it was decided that in tenancy situations controlled by the TP Act, the dispute would be settled by a civil court rather than an arbitrator.

As a result, the Court decided that landlord-tenant disputes are arbitrable because the TP Act does not forbid or foreclose arbitration. Further, landlord-tenant disputes have nothing to do with the State's intrinsic and sovereign functions. However, when a specific court or forum has been given exclusive authority to apply and decide special rights and obligations, landlord-tenant disputes covered and governed by rent control legislation would not be arbitrable. Only the designated court/forum can adjudicate and enforce such rights and duties; and not arbitration.

Let us see when the issue of non-arbitrability can be raised.

1. Before the court on an application for reference under Section 11 or for stay of pending judicial proceedings and reference under Section 8 of the Arbitration Act;

2. Before the arbitral tribunal during the course of the arbitration proceedings; or

3. Before the court at the stage of the challenge to the award or its enforcement.

In light of the legislative mandate clear from the amendments to the Arbitration and Conciliation Act, 1996 by Act 3 of 2016 and Act 33 of 2019, as well as the principles of severability and competence-competence, the general rule and principle is that the arbitral tribunal is the preferred first authority to determine and decide all questions of non-arbitrability. In terms of sub-clauses I (ii), or (iv) of Section 34(2)(a) or sub-clause I of Section 34(2)(b) of the Arbitration Act, the court has been given the jurisdiction to "second look" at aspects of non-arbitrability after the award.

The arbitral tribunal is seen to be the preferred first authority for determining and deciding all non-arbitrability issues. Section 34 of the Arbitration Act gives the courts the power to take a "second look" at aspects of non-arbitrability after the award has been made. The Court further adds that when it is obviously and ex facie certain that the arbitration agreement is non-existent, unlawful, or the disputes are non-arbitrable, the court may intervene at the Section 8 or Section 11 stage as a demurrer. However, the level and character of judicial scrutiny would be determined to some extent by the nature and aspect of non-arbitrability. This restricted and limited review is solely in place to ensure that parties are not forced to arbitrate when the subject is demonstrably 'non-arbitrable.' The Court's pro-arbitration stance has contributed to greater clarity in determining when statutes expressly exclude arbitration and when they do not.

2. Lok Adalats in India- Hierarchy and Types

In India, where there is a pendency of more than 4.5 crore cases which has supervened in a delay of justice and as a result of which if this problem is not resolved at the earliest, it would result in a state of lawlessness and, therefore to avoid this problem, the legislation came up with the committee formed under the chairmanship of Justice P N Bhagwati who finally brought Lok Adalats into the picture. The Legal Services Authority Act, 1987 is umbrella legislation, constituting one of the methods of Alternate Dispute Redressal Mechanisms, i.e., Lok Adalat. The provisions that deal with Lok Adalat are given under chapter VI of the Legal Services Authority Act, 1987. Lok Adalat provides a speedy trial to cases pending at a pre-litigation stage in the courts which are settled or compromised on the Lok Adalat amicably and without going through the time taking and expensive procedure of the courts, thus have proved to be one of the most effective ways of solving disputes over the last few decades.

Lok Adalat works at the ground level. The functioning is also divided into different levels and kinds of Lok Adalat, including Lok Adalat at the State Authority Level, High Court Level, the District Level, and the Taluk Level. They are further divided into National Lok Adalat, Permanent Lok Adalat, Mobile Lok Adalat, Continuous Lok Adalat, Daily Lok Adalat, and Mega Lok Adalat.

Hierarchy of the Authorities for Lok Adalat under NALSA

Under the Act, different authorities have been empowered to carry out its objects. National Legal Services Authority is the supreme body and is empowered to lay down programs and principles for making legal services available under the Act. It also frames the most effective and provident schemes for legal services. It also distributes finances and subventions to State Legal Services Authorities and NGOs for enforcing legal aid schemes and programs. In each State, a State Legal Services Authority is constituted to give effect to the program and directions of the Central Authority (NALSA). They also have to conduct legal services to the people and conduct Lok Adalats in the State. The State Legal Services Authority is guided and headed by the Chief Justice of the separate State High Court that serves as its Patron-in-Chief. The Next Senior most

Judge of the independent High Court or retired Judge of the High Court is nominated as its Administrative President.

In each District of the State, District Legal Services Authority is empowered to apply Legal Aid Programmes and Schemes in the District. The District Judge of the District is its ex-officio Chairman. Also, Taluk Legal Services Panels are constituted for each Taluk Mandal or for a group of Taluk or Mandals to coordinate the conditioning of legal services in the Taluk and organize Lok Adalats. Every Taluk Legal Services Committee is headed by an elderly Civil Judge or a Junior Civil Judge, as the case may be.

Types of Lok Adalat-

1. Regular Lok Adalat- Regular Lok Adalats are further classified into different Lok Adalats

<u>Continuous Lok Adalat</u>- A Lok Adalat bench sits continuously for a set number of days to grease agreements by remitting unsettled matters to the succeeding date and encouraging parties to reflect on the terms of the mutually accepted agreement before the factual agreement.

Daily Lok Adalat: This type of Lok Adalat is organized daily.

<u>Mobile Lok Adalat</u>: These are organized by taking the Lok Adalat set up in a Multi-utility van to different areas to resolve petty cases and spread legal mindfulness in the area.

Mega Lok Adalat: This is organized in the State on a single day in all courts of the State.

The total number of regular Lok Adalats held till 2016 is 1,67,586, whereas the compensation paid is Rs 27,15,53,48,516.

2. <u>Permanent Lok Adalat-</u> The other type of Lok Adalat is the Permanent Lok Adalat, organized under Section 22-B of The Legal Services Authorities Act, 1987. Permanent Lok Adalats have been set up as bodies with a Chairman and two members for furnishing a mandatory prelitigation procedure for conciliation and agreement of cases relating to Public Utility Services like transport, postal, telegraph, etc. The governance of the Permanent Lok Adalats is up to Rs. One Crore. Then if the parties fail to reach an agreement, the Permanent Lok Adalat has the government decide the case. The award of the Permanent Lok Adalat is final and binding upon the parties. The Lok Adalat may conduct the proceedings in such a manner as it considers applicable, taking into account the circumstances of the case, wishes of the parties like requests to hear oral statements, speedy agreement of dispute, etc.

The total number of permanent Lok Adalats established in 2016 is 292; 239 are working. The total number of cases disposed of are 1,03,559, and the compensation provided is 23,87,00,291

3. <u>National Lok Adalat</u>- Under this type, Lok Adalats are organized throughout the country from Supreme Court to Taluk Level, and numerous cases are disposed of on a single day. Such Lok Adalats are held at regular intervals.

Since the country's legal system is experiencing a surge in cases day by day, the establishment of Lok Adalats has proved to be a blessing to the country. The bifurcation of Lok Adalat has helped the authorities to work more systematically and therefore dispose of cases more speedily and efficiently.
