This course was designed to introduce the basic commands, functions, and capabilities of Microsoft Excel used in business. This course helped students to understand and utilize the various functions of MS Excel and enable them to become more efficient in the workplace. It was very practical and interactive course. The certificate course was headed by Ms. Sarita Garg, Associate Professor & Head, Department of Economics. The resource persons of this course was Ms. Neetu Aggarwal, Assistant Professor, Department of Business Administration; Dr. Sushila Gupta, Assistant Professor, Department of Business Administration; Dr. Sangeeta Rawal, Assistant Professor, Department of Business Administration. In total 49 students registered for the course and all the students successfully completed the course. Criteria of certification was threefold i.e., Attendance, Feedback form and Completion of both assignments and quizzes consisting of objective and subjective questions during the course.

The course covered the topics Introduction to spread sheets, Basic text and self-formatting, Basic arithmetic calculations, Sort and filter, Charts, Conditional formatting, Functions (Mathematical, Logical, String, Date and time), V look-up and H look-up, Managing worksheets, Tables, Data tools, Referencing formulas, Conditional Logic and Pivot Tables. Topics were chosen keeping in mind the requirements of students in further studies and research.

Such courses provide expert guidance to students & helps them in building their resume. Knowledge of excel has become the essential part of every business and job.
