ABOUT COURSE

Gender, Inequality, Intersectionality and Social Action is an intensive online certificate course offered by Maharaja Agrasen Institute of Management Studies that aims to provide a feminist understanding of gendered human relations in contemporary India. Sex and gender-based discrimination is a real problem in today's world. Despite years of change that have seen women's suffrage spread, women rising to the highest positions in politics and industry (albeit in limited numbers), and anti-discrimination laws implemented in many parts of the world, we can hardly claim to have achieved anything like true equality. This is a type of systemic violence that thrives on patriarchy and biases that are justified, maintained, and passed down through the generations. More than half of the world's population, namely women, transwomen, alongside other trans and nonbinary people, face even greater challenges. The proposed course will look at issues through the lens of India's diversity, as well as an attempt to understand power relations—historical, structural, economic, and political—that define the male and female relationship in a socio-cultural context, and that originate from deeply rooted patriarchy and age-old dominance structures.

COURSE STRUCTURE

Fourteen modules have been chosen and experts across disciplines and professions engaged in gender-related development in India will address the ways in which gender is understood, constructed, and performed. Drawing from a variety of perspectives –Women Studies, Economics, Law, Psychology, Politics, Social Policy, and Sociology participating in the teaching of the modules. On completion of the course, students should demonstrate an interdisciplinary understanding of the diverse gender issues in contemporary India. They should be able to question the existing stereotypes and critically evaluate patriarchal social practices.

LEARNING OUTCOMES

- To provide a comprehensive understanding of gender disparities and inequalities in society.
- To develop an understanding about the relationship between gender, law, and society
- To evaluate the impact of laws upon gender equality.
- To have a basic understanding of how feminist philosophy can be applied to the law.
- To enable students to think critically on gendered experiences across the spectrum of daily life and understand power relations through a gender lens.

DESCRIPTION OF MODULES

Module 1. Constructing Gender

Every aspect of an individual's and society's economic, social, everyday, and private lives, as well as the different roles given to men and women by society, is influenced by gender. Participants in this module will explore various topics such as gender binary, gender inequality, gender stereotype, gender identity, patriarchy, masculinity, and so on.

Module 2. Gender Equality and the Law

The participants in the Gender Equality and the Law module will gain a better understanding of current events, with topics such as reproductive rights (abortion, surrogacy, and emerging reproductive technologies), sexual harassment, body image and pornography, prostitution, parity democracy, and maternal rights.

Module 3 Gender Mainstreaming

The participants in this module will investigate gender equality perspective is embedded in all policies at all levels and stages, by the actors usually involved in policy-making.

Module 4 Gender Gaps in STEM: Science Technology Engineering and Mathematics

Gender bias is prevalent in STEM fields. Participants in this module will learn What are the challenges that women face when deciding to pursue a STEM education? What can universities do to encourage more women to pursue and succeed in STEM fields?

Module 5 Gender inequality in Politics

Participants will learn about the relationship between gender and politics, including how gender stereotypes can still apply to political allegiances and disparities in gender representation in democratic societies and gender-egalitarian countries. They will also learn about the historical trends of women gaining the right to vote, as well as how they have progressed to the status of elected officials.

Module 6 Gender and Economy

Gender Economics is an academic discipline that is concerned with women's equality with men and women's growth. In this module participants will understand gender and economics to meet their needs, emphasising the importance of providing a normative framework for women's independence and autonomy.

Module 7 Gender Representation in Media

Participants in this module will learn how the media creates images of femininity, masculinity, and gender relations, as well as the discourse over responsibility and the relationship between censorship and media.

Module 8 Gender Intersection: Caste, Class and Gender Violence in India

This module contextualises the social, political, and economic context in order to comprehend the effect of caste and class on gender violence in India, especially the intersectionality of caste and class.

Module 9 Women, Gender and Feminist Struggle in India

Participants in this module explore the main issues relevant to the feminist struggle over the last three decades. It will not only discuss the achievements of these struggles, but it will also address issues such as India's low sex ratio of women to men, violence against women, the demand for equality in legislative bodies, and the fight for the rights of sexual minorities.

Module 10 Gender Justice: Feminist Jurisprudence

This course will examine discrimination based on sex and non-heterosexuality in current law and judicial decisions. It also investigates the jurisprudential reasons for the current state of affairs. It reflects on the patriarchal nature of the state and family, as well as current feminist and queer debates.

Module 11 Gender Justice: Feminist Jurisprudence

This module will address the issue of women's disparity through its structural, social, and cultural origins in both the workplace and the home, as well as how inequality faced by women at work, which had a negative impact on their employment, was exacerbated by another profound inequity — the one at home.

Module 12 Gender and LGBTQ Rights

In this module, the participants will be able to explore the history of LGBTQ around the world, local histories of queer and transgender people and communities, and how LGBTQ histories have influenced broader debates about human rights, equality, and justice in this module.

Module 13 Gender and Development

The aim of this module is to investigate the relationship between development and gender. It will provide statistics on the current state of women and men in our society, as well as references to important documents that illustrate policies designed to resolve gender issues.

Module 14 Gender and Health

In this module, participants will understand the relationship between gender and health. How have government policies dealt with the problem of women's health? and how it affects women's status in Indian society?

DURATION

The duration of each module is 2 hours. Two modules per week will be conducted and the course will be spread over a period of two months: June and July. The class timing is going to be between 3:00 p.m. and 5:00 p.m.

Dr. Anu Mehra, Associate Professor Law Centre-I, Faculty of Law, University of Delhi, New Delhi


