






About Department of Law

In order to open more avenues MAIMS, Department of Law introduced LLM (Master of Law) in Intellectual Property Rights from this year. MAIMS 3rd National Moot Court Competition 2022

Maharaja Agrasen Institute of Management Studies 3rd National Moot Court Competition, 2022, aims to provide a platform for students across India to showcase their advocacy and research skills by competing in a professional and challenging environment. The purpose of organizing this competition is to help the participants nurture their prime advocacy skills. The Department of Law, MAIMS has been successful in organizing several mega-events in the recent past, including Intra Moot Court Competition (2019). Intra Trial Advocacy Competition (2020), 1st National Moot Court Competition (2020), 2nd National Moot Court Competition (2021), as well as various Induction Moot Court Competitions. The Inaugural Ceremony of the event will be organised on November 11, 2022 in virtual mode followed by the Preliminary Rounds & Quarter Final Rounds on November 12, 2022. The qualifying teams shall be competing in Physical Mode in the premises of Maharaja Agrasen Institute of Management Studies, Rohini, Delhi on November 26, 2022.

ABOUT MOOT COURT

A moot court is like simulating a real court, where students are made to participate in the staged court proceedings that are related to a fictional dispute between parties. A moot court competition provides the students with a basic platform for facing the professional rivalry qualifying which requires a few steps. The teams learn professional tactics from dressing to professionally tackling the international matters. By the end of their mooting journey their skills and legal knowledge is fully boosted and enhanced.

OBJECTIVES

- To engage with and think deeply about interesting and topical legal issues;
- To enhance their advocacy, legal research and writing skills;
- To work closely with and learn from their peers; and
- To demonstrate their interest in advocacy and competence as an advocate to prospective employers.

COMPETITION GUIDELINES



The MAIMS 3rd National Moot Court Competition, 2022, will be held in a Hybrid Mode from 11th November - 26th November 2022.

- The competition is open for students who are pursuing LL. B three-year / five-year course during the current academic year.
- Only one team is permitted to participate from each participating Institution.
- Each team shall consist of three members. This number cannot be modified under any circumstances.
- In a team consisting of three members, two members shall be designated as 'Speakers,'
 and the third member shall be designated as 'Researcher.
- All the participating teams must confirm participation by filling a Registration Form on or before October 2, 2022. For Registration <u>Click here</u>
- As per the rules, each team upon completition of registration shall be allotted a unique Team Code for the competition. Each team must use the Team Code for further communication with the organizers during the course of the competition.
- Any change in team composition must be intimated to the Organizer at the earliest through e-mail (mootcourtsociety@maims.ac.in). Such change must be accompanied by a freshly filled registration form.
- Participants will receive an approval email, signifying the acceptance of their request for participation latest by October 5, 2022.
- The participating teams are required to pay Rs. 3,500/- as registration fees.

The Last Date for Payment of Registration Fees is October 2, 2022.

II. STRUCTURE OF COMPETITION

The Competition shall consist of four rounds:

- 1. Preliminary Rounds
- 2. Quarter Final Rounds
- 3. Semi-Finale Rounds
- 4. Final Round

PRILIMINARY ROUNDS

The preliminary round will be held on 12th November, 2022 in Online Mode. All the teams will compete twice in the preliminary rounds. After competing, the best 8 teams will advance to the quarter-final round.

QUARTER ROUNDS

The best eight teams will qualify for the quarter-final, which will be held on 12th November, 2022 in Online Mode. After competing, the top 4 teams will advance to the semi-final round.

SEMI-FINALE ROUNDS

The best four teams will qualify for the semi-final, which will be held on 26th November, 2022 in Offline Mode. After competing, the top 2 teams will advance to the final round.

FINAL ROUND

The final round will be held on 26th November, 2022 in Offline Mode. The best two teams will qualify for the finals. After competing, the team with the highest score will be announced as thebest team.


