As the classes of 1<sup>st</sup> year students had already been commenced from October 3, 2022 for all the existing courses admitted through centralized online counseling or through management quota. In view of the above, the second round of counseling for the remaining vacant seats will be held on October 18, 2022. The details of the same are as follows.

It is notified that only 04 seats were left vacant in BA LLB (H) program, 01 vacancy in BBA LLB (H) program and 01 vacancy in BA (Eco) (H) (due to the non-payment of Institute fees by Ms. Mehak to whom seat in BA (Eco)(H)-1<sup>st</sup> shift was allotted during 1<sup>st</sup> round of counseling) for taking admission under management quota for the academic session 2022-23 after first round of counseling held on October 01, 2022.

Interested candidates who have neither admitted nor allotted any seat during regular rounds of online counseling done by GGSIPU shall report physically in the Institute for filling up the above mentioned vacant seats on October 18, 2022 by 10:00 AM along with all the required documents.

The second round of counseling for the above seat will commence at 10:30 AM in Room No.942 (Block 9).
