NATIONAL VOTERS RIGHTS DAY

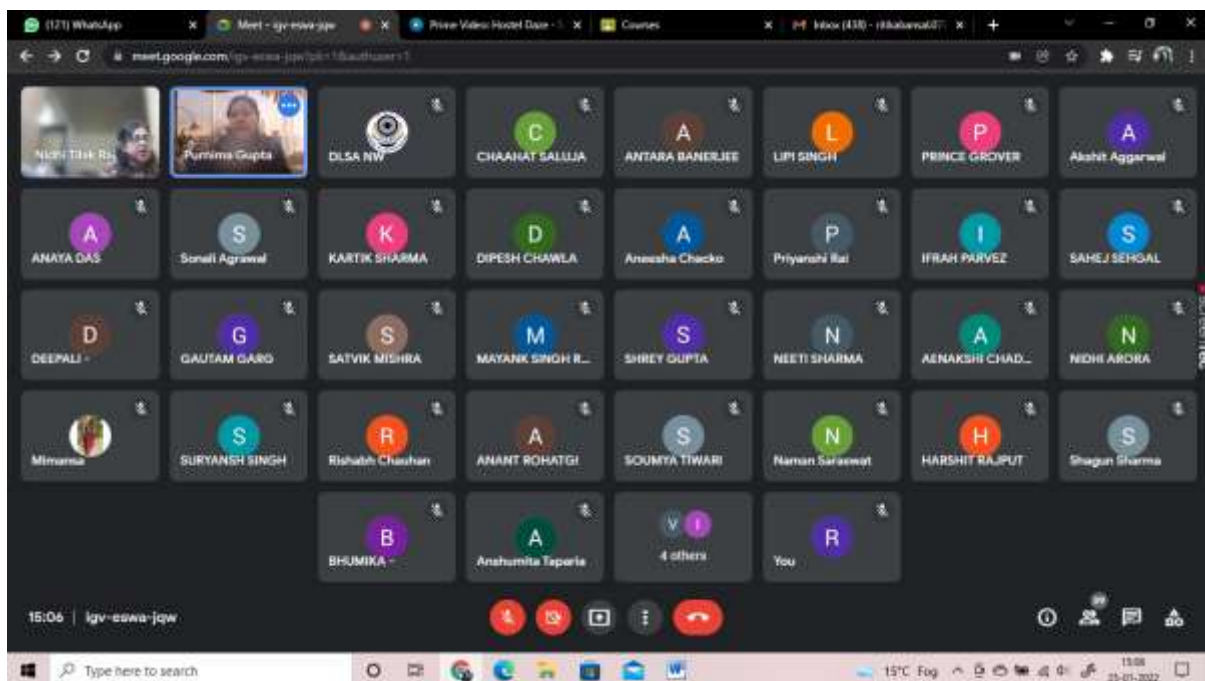
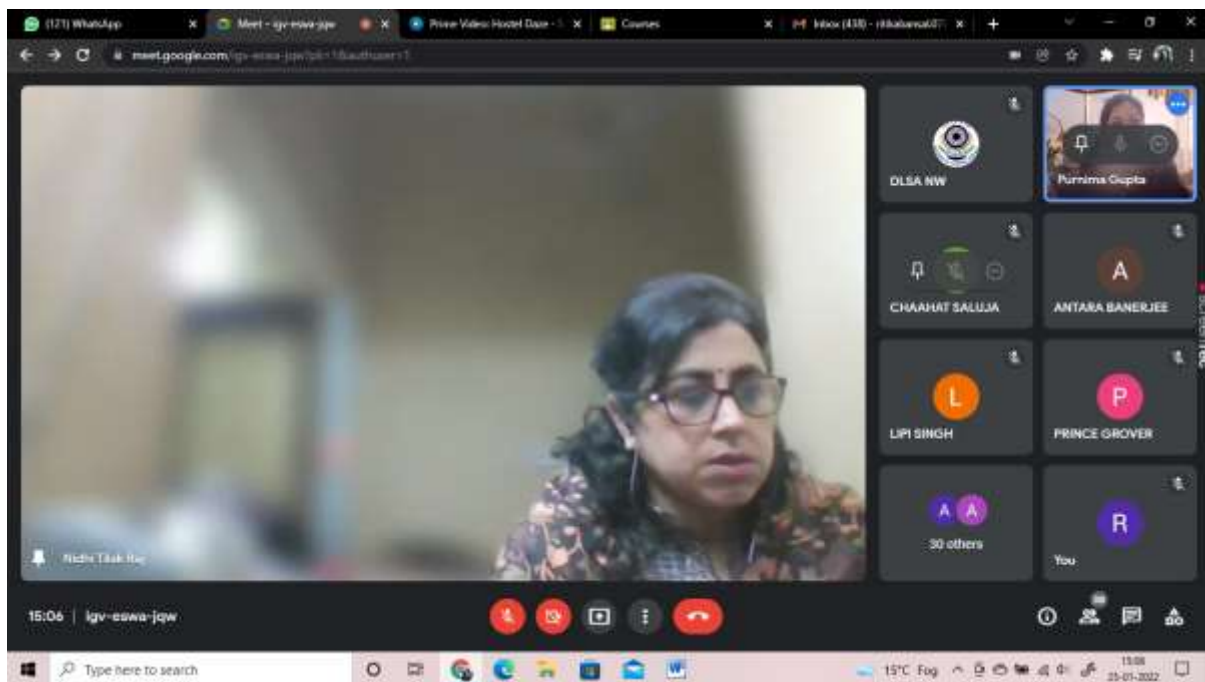
On 25.1.2022, Maharaja Agrasen Institute of Management Studies, Department of Law on the occasion of Republic Day and National Voter's Day, in collaboration with North West DLSA and Legal Services Clinic, Vidhi Mitra MAIMS, Department of Law organized a guest lecture on Overview of Mediation. The speaker for the session was Ms. Nidhi T. Raj. She is an advocate and is also practicing as a mediator in Delhi District Courts and High Court of Delhi.

The entire session was moderated by Ms. Purnima Gupta, Coordinator of the session and Senior Assistant professor, MAIMS with a welcome note to our Resource person.

She started the session by giving an overview of the Indian Constitution and how our Constitution enshrines the provisions to provide justice to everyone in the society and hence why mediation is emerging as an important Alternate Dispute Resolution Method and why it should be adopted over litigation. She further emphasized the importance of mediation stating that it is a friendly method in which both the parties are in a win-win situation and also less hectic and time-consuming than the traditional trial method. She also explained how mediation is a voluntary and structured process in which a neutral third party conducts the proceedings using specialized knowledge and communication techniques and resolves the disputes amicably.

In the end a virtual tour of the mediation center of the Rohini court was given and she further elaborated on the process of mediation and the stages involved in the process such as the opening session, joint session, caucus, and closing session followed by the mediation settlement agreement drafted by the mediator and signed by the parties. The entire session was structured through Power Point presentation in such a way that was very brief and also easily understood by all the students. The session proved to be very insightful to all the students and after the conclusion of the session, the queries of the students were taken and was being answered.

The session was concluded by a vote of thanks given by our faculty coordinator Ms. Purnima Gupta.

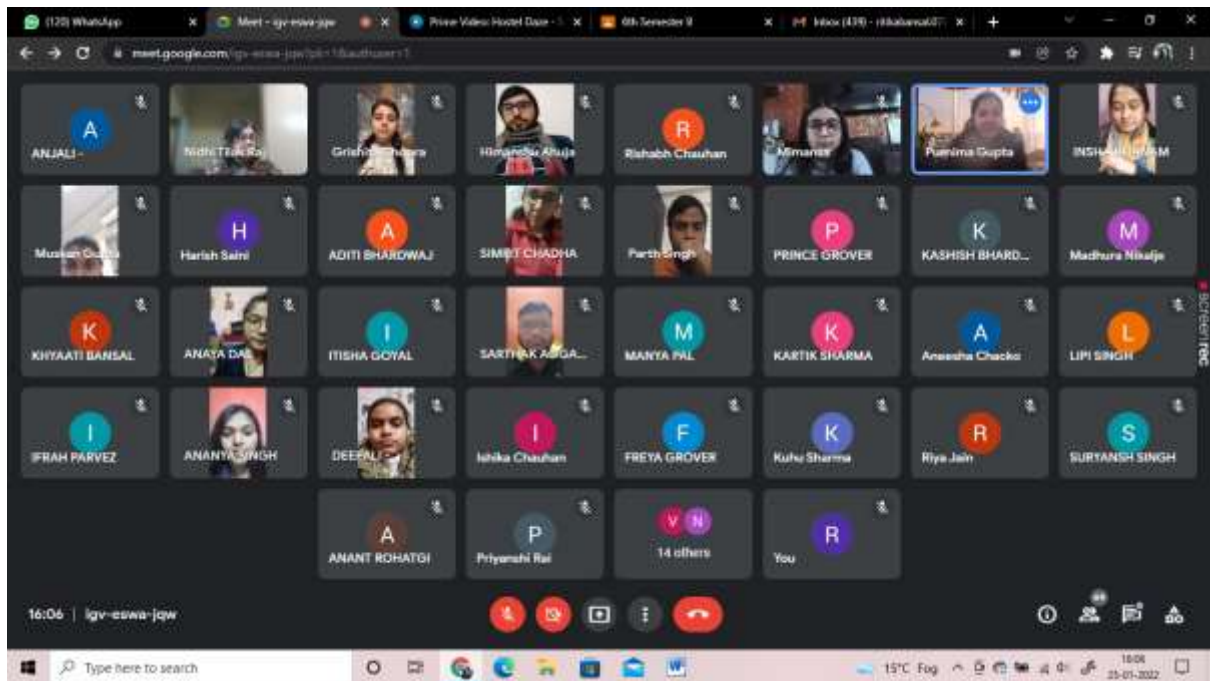
