### Value Added Course on

#### "CYBER SECURITY"

## 2nd September-30th November 2019

Maharaja Agrasen Institute of Management Studies, Department of Commerce started a Student Training Programme "CYBERSECURITY". The course was started for the undergraduate students of MAIMS and other institutes. Registration for the same began on 16<sup>th</sup> August, 2019 and classes started from 2<sup>nd</sup> September, 2019 and ended on 18th October, 2019. With 15 sessions of 2 hours each, the course was of 30 hours duration in total. The valedictory of the course was conducted on 30th November 2019.

This course is aimed at familiarize students with current cyber security landscape, Gain insights into relevant tools to assess and manage security protocols in information processing systems, Develop knowledge on Cloud Security, make students acquainted with the process of identifying potential risks, assess the impact, and respond effectively to cyber threats.

The certificate course was headed and convened by Ms. Rachita Aggarwal. Dr. Geetanjali Gupta, Mr. Praveen Kumar Singh, Ms. Rashi Aggarwal, Ms. Sarita Garg, acted as the resource person for the course covering various topics of cyber security as per their expertise. In total 123 students registered for the course. The course was conducted in 2 batches because of 123 students. The classes of 1st Batch were conducted on Monday, Wednesday and Friday and the classes of 2nd Batch were conducted on Tuesday, Thursday and Saturday. All the classes were offline. The timings of the classes were 2:30 pm to 4:30 pm.

The course had been started with the Introduction to Information Security, it moved to Introduction to Cyber Security, Cyber Security Fundamentals, then it discussed about Information System Governance & Risk Management, Now time to discuss the Risk Management, Incident Management, Cloud Security, Disaster Recovery, Key impacts of cybercrime, Popular Attacks- Hacker's Motivation, Popular Attacks. Almost all the topics were covered by resource persons in detail.

Certificates were given only to such students who successfully qualified all the four parameters namely, Attendance, feedback forms, Assignments and Quizzes. Total 123 students across the country have registered for this course and have qualified all the above stated parameters.

Such courses provide expert guidance to students & help them in building their resume. It gives them an edge over others when it comes to working in the corporate world. It helps the students in acquainting themselves with fundamentals of cyber security and to protect them from the frauds. The
