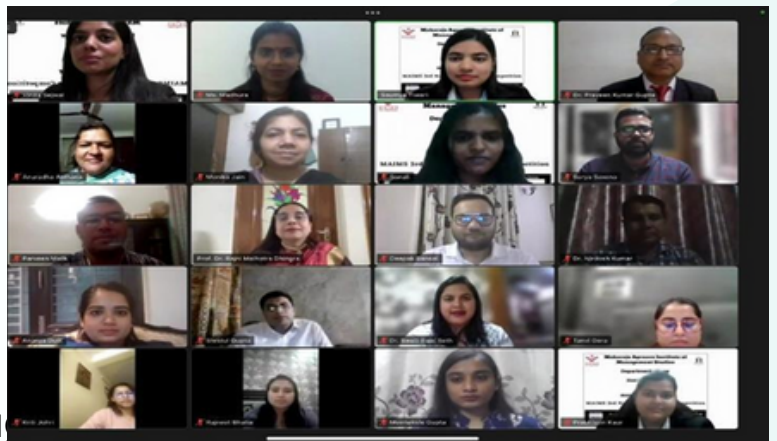




# 3RD NATIONAL MOOT COURT COMPETITION (11TH -12TH NOVEMBER & 26TH NOVEMBER 2022)

The preliminary and Quarter Final rounds were conducted in online mode on 11th and 12th of November. The semi-final and final rounds were conducted in the Campus itself. A total of 49 teams competed for this. The inaugural ceremony of the event was conducted virtually on 11th November, 2022. The event was graced by the presence of Chief Guest Mr. Priyank Konoongo, Chairperson of National Commission for Protection of Child Rights. It was a privilege to have Former Hon’ble Ms. Justice Asha Menon, Delhi High Court as the Guest of Honor. Dr. Nand Kishore Garg, Founder Chairman, MATES, Prof. (Dr.) S.K. Garg, Director General, MAIMS, Prof. (Dr.) Rajni Malhotra Dhingra, Director, MAIMS, Dr. Praveen Kumar Gupta, HOD, Department of Law, MAIMS were also present to galvanize the contending members and students of Department of Law, MAIMS.

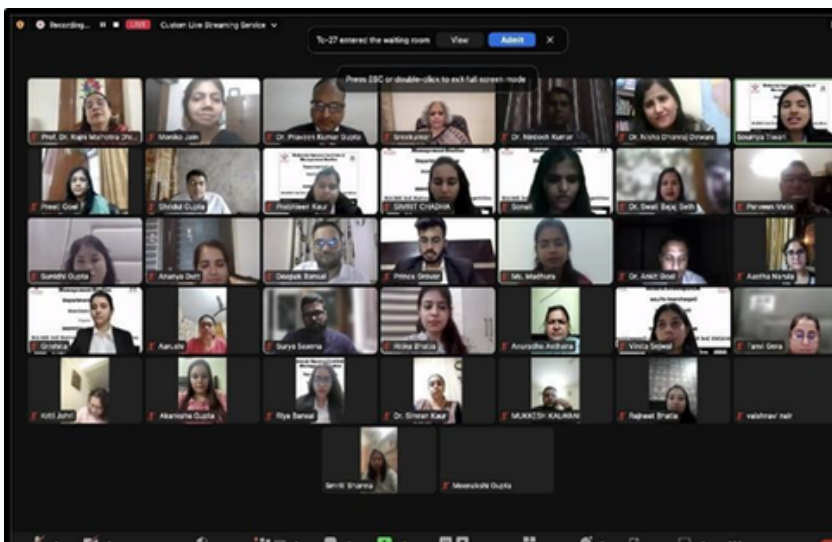
Convener of the event, Dr. Nisha Dhanraj Dewani, Associate Professor, Department of Law MAIMS, apprised the audience about the 3-day mega event of 3rd NMCC. Dr. Praveen Kumar Gupta, Head, Department of law raised the spirit of participants by encouraging them to participate in the Moot Court Competition with the spirit to give their best irrespective of the result of the competition and wished them the best for the competition.



While addressing the gathering, Prof. (Dr.) S K Garg, Director-General, MAIMS, presented the idea that the Moot Court competition should be analyzed and judged by the students of final year as to understand through the eyes of Judges and to get a better understanding of the Competition. He also praised mooting activity for law students as he felt this promotes their interest in handling real-life litigation.

Our Guest of Honor, Former Hon'ble Ms. Justice Asha Menon threw light on the Importance of reading Full judgements as it reflects in a good way in the life of a law student. She also encouraged the students to take part in the Judgement reading Competition and also emphasized the importance of the Mooting.

Chief Guest of the occasion, Mr. Priyank Konoongo shared with the students that they were lucky to have the experience of mooting while in college. He said that this would help them in their law career.

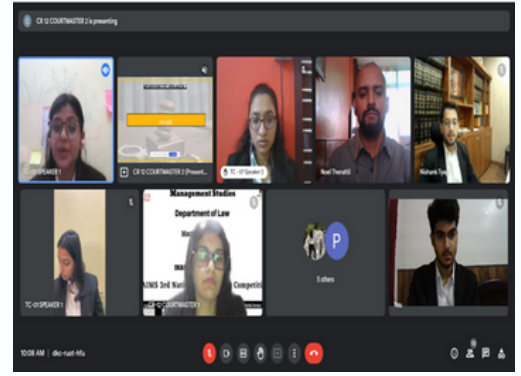


With this he wished everyone the best. He also asked the students to give back to society what they were getting today as Law Students. Dr. Nand Kishore Garg shared that Judges can serve honest judgment but the lawyers have to modify themselves

according to the needs of their clients so it's a very tough path for lawyers in a society where crimes are increasing at a very rapid rate. At the end, Vote of Thanks was proposed by Prof. (Dr.) Rajni Malhotra Dhingra, Director, MAIMS. The student coordinators conducted the Draw of Lots and the participating teams received the teams' matrix for the Preliminary rounds which commenced on 12th November 2022.

# DAY 2: PRELIMINARY AND QUARTER FINAL ROUNDS

On 12th November 2022, the Preliminary rounds were held followed by the Quarter-Final round which was held with great zeal, vehemence and credence. A total of 49 participated with enthusiasm and research. The day started with a Researcher's Test that took place early in the morning. A total of 57 judges ruled the proceedings in courts in good faith. The jury included prominent independent Attorneys and partners from leading law firms. Later, Dr. Deepa Kaushik, Faculty of Law MAIMS announced the results where 8 teams qualified for the Quarter Final Rounds. A total of 8 major legal entities adjudicated in 4 courtrooms in Quarter-Finals. The aforementioned round was a knockout round, and the winning team of that round advanced to the semi-finals. The results for the Quarter Final Rounds were declared by Dr. Swati Bajaj Seth, Faculty of Law MAIMS.



Four teams which qualified for the semi-final round were-

1. The University of Petroleum and Energy Studies, Dehradun, (TC-29)
2. Ramaiah College of Law, Bengaluru, (TC-15)
3. Symbiosis Law School, Noida, (TC-22)
4. School of Indian Legal Thought, Kerala. (TC-48)

The Semi-final and the Final rounds were conducted in the ninth block of Maharaja Agrasen Institute of Management Studies on 26th November, 2022 with well-bifurcated time schedules. There were overall two court-rooms therein for the conduction of the event.

The Moot Court Room 1 witnessed the proceeding of Group-A (SLS Noida v. UPES, Dehradun) chaired by Honorable Justices, Harshit Jain, Sakshi Kakkar, and Uday Bir Singh, while Moot Court Room 2 had the case proceeding of Group- B (Ramaiah College of Law, Bengaluru, v. School of Indian Legal Thought, Kerala), chaired by the honorable bench of Justices, Dr. Anant Vijay Maria, Mr. Nishant Das and Dr. ShaliniTyagi.

Both the court-rooms commenced the proceedings with all due respect to the respective honorable lordships, irrespective of any substantial delay at 09:55 hours. The case proceeding was started with the Petitioners' side presenting their case in front of the honorable lordships along with the respondents' side, followed by their counter-arguments. Both the sides were provided with a limited time frame under which they were supposed to explain the concerned issues of the case, followed by appropriate arguments in favour/against of the concerned case.

At last, the moot court-rooms were successfully culminated with the permission of the honourable lordships, with both petitioners' and respondents' side presenting their issues and arguments. The event was concluded under the given time frame. The honourable judges thereby finalized the Semi-final round for both the groups of the court-rooms, by providing their valuable feedback and sound appreciation at 11:55 hours.

The Final Round:

Same day the Final round took place. Another occasion saw the eagerness and rivalry of the aspiring attorneys in the MAIMS moot courtroom. The honourable bench of Justices, Dr. N K Bahl, Dr. UpmaGautam, and Mr. A.K. Chaturvedi, presided over the finals, which were held between The Symbiosis Law School, Noida (TC-22) and the School of Indian Legal Thought, Kerala (TC-48). Regardless of any significant delays, the courtroom opened the proceedings at 1 PM with all due respect to the various honourable lordships. The case proceeding began with the Petitioners' side and the Respondents' side each stating their case in front of the honourable lordships, followed by their counter-arguments.

## Highlights of the proceeding:

1. The honourable bench checked and corrected counsel-1 for the petitioners on the matter of section 123(1) (a) of the Delhi Representation Act.

2. The honourable bench checked and corrected counsel-2 for the respondents on the issue of entitlement to compensation based on right to privacy as per article 21 of the Indian Constitution.

3. In the case of Mr. Waterman v. Mr. Sarvesh and Sections 8(a), 123, and 123(1) (a) of the People's Representation Act, the honourable bench questioned the validity of irrational freebies and violations of RPI about holding elections.

Following that, the Sur Rebuttals were presented to the honourable bench in order to address the concerns raised by the counsel.

With the honourable lordships' approval, the mock courtrooms were successfully concluded, with the petitioners' and respondents' sides stating their points of contention. The event was over in the allotted amount of time. At 15:30, the distinguished judges concluded the Final round of the courtroom by offering their insightful comments and encouraging praise.

Valedictory Ceremony of 3rd NMCC and Celebration of Constitution Day, 26th November 2022

After the 3rd Moot Court Competition's triumphant conclusion, all of the faculty and students gathered in the Maharaja Agrasen Auditorium with the honourable dignitaries for the event's valedictory ceremony.

This was followed by the celebration of India's Constitution Day on November 26 in 2022. Honorable Mr. Justice Sachin Dutta and Prof. Amanullah Mukhamedjanov from the Tashkent Law University, were the Guests of Honor, while Honourable Mr. Justice Chandra Dhari Singh was the Chief Guest of the event. Dr. Nand Kishore Garg, Founder and Chief Advisor, MATES, Shri Vineet Kumar Lohia, Chairman MATES, Prof. (Dr.) SK Garg Director General MAIMS, and Prof. (Dr.) Rajni M Dhingra, Director, MAIMS graced the occasion.



The Preamble recitation ceremony of the Indian Constitution, was the most important and inspirational event of the evening. It was conducted by the Head, Department of Law, Dr. Praveen Kumar Gupta. The Preamble which is a miniature constitution, empowers each and every citizen of India.

We were pleased to have a Guest of Honour from across the borders, from the state of Uzbekistan, Central Asia, and Prof. (Dr.) Amanullah Mukhamed Janov. He teaches at the Tashkent Law University, Uzbekistan. He emphasized upon the Indo-Uzbek relations and the significance of law in the modern world. He stated that a project to translate the Indian Constitution in Uzbek language was underway.

It was indeed a matter of pride for all of us. Justice Sachin Dutta, Delhi High Court, then discussed important guidelines for a better and enhanced manner of living as well as the implementation of the law in the current world, notably India. The Chief Guest of the occasion Justice Chandra Dhari Singh, Delhi High Court, commented on legal principles from his point of view as well as the significance of law and litigation in India. Dr. Nand kishore Garg, Founder and Chief Advisor, MATES also made connections between Indian history and the legal system, focusing on the importance of grassroots reformation in India, which would be useless without a just and honourable society.

# VISIT TO THE PARLIAMENT OF INDIA AND PRIME MINISTER'S MUSEUM 23RD NOVEMBER 2022

The Department of Law organized a visit to the Parliament of India and the Prime Minister's Museum on 22nd November 2022 for the students of BALLB 1st Semester as a part of an educational trip. There were a total of seventy students accompanied by faculty members of the Department of Law.

The students reached the Institute early in the morning and from there proceeded for the Parliament in two buses. It took about one and a half hour to reach there. After a strict security check, we were allowed entry to this sacred temple of democracy. Dr. V.K. Bhatnagar, Adjunct Professor of the Department of Law who has also served as Joint Secretary in the Lok Sabha liaising with the officials of the Parliament for necessary arrangements and permissions. Dr. Anuradha Asthana Singh, Dr. Nirdosh Kumar, Ms. Kriti Johri, Mr. Parveen Malik and Ms. Meenakshi Gupta were the Faculty members who escorted the students. Mr. Rakesh Chaurasia, the PRO of Maharaja Agrasen Technical Education Society also accompanied the students and the Faculty members.

At first the students were taken for a briefing session in the Committee Room A. There Dr. Raj Kumar, Director, PRIDE briefed the students about the Parliament and its Houses. Thereafter Dr. Deepak Gosain, Retired Director, PRIDE explained to the students the Constitutional Development of our country in a very lucid manner. Mr. Rajkumar Patton coordinated the event perfectly.

After the briefing students were taken to the Banquet Hall where refreshments were given and students as well as the Faculty members got an opportunity to interact with Dr. Raj Kumar and Dr. Deepak Gosain.

After the briefing the students were taken to the Lok Sabha (the Lower House) and the Rajya Sabha (the Upper House). The Watch and Ward officers briefed in detail about the formation, functioning, the sitting arrangement, the media gallery and the guest galleries. The significance of red color for the Rajya Sabha and the Green colour for the Lok Sabha was also explained.

Thereafter the students were taken to the Central Hall of the Parliament. This hall is central to the erection of our political structures that defined independent India, the adoption of tricolor, the adoption of our national anthem and the drafting of our Constitution. All of us were amazed at its aura and attraction. The writing "Vasudhaiva Kutumbakam" is seen above the entrance wall at the Centre hall's entryway. High tea was served to the group in the Parliament's banquet room.

The trip's aim was to help the students learn how the Lok Sabha and Rajya Sabha work. The visit was a special occasion, not only for seeing the elaborate building, but also for learning more about Indian legislation and the legislative process.

After visiting the Central Hall, the students visited the Parliament Library, one of the richest repositories of books in India, which was established in the year 1921 to assist the members of the Indian legislature. After that the students had a sumptuous lunch in the Parliament Canteen.

Our next destination was the recently opened Prime Minister's Museum or the " PradhanMantriSangrahalaya" in the Teen Murti Complex of Lutyen's Delhi. The museum was inaugurated by our Honourable Prime Minister ShriNarendraModiji on 14th April 2022 as a part of the "Amrit Mahotsava Celebrations". The logo of the Sangrahalaya shows hands holding Dharma Chakra symbolizing the nation and democracy. The design of the Museum is sustainable and it incorporates energy conservation practices.



From the freedom struggle to the framing of the Constitution, from independence and the post-independence era till now the Museum has showcased various Prime-Ministers---their achievements and landmarks achieved during their tenures. Personal gift items and Memorabilia received by the PMs is also on the display. It also has holograms, virtual reality, augmented reality, interactive screens etc. to make the exhibition contents interactive.

By 4pm we completed our visit and then returned back to the Institute. It was a memorable visit as well as knowledgeable one.





# INAUGURATION OF PRO-BONO CLUB

## 17TH DECEMBER, 2022

Maharaja Agrasen Institute of Management Studies conducted the highly prestigious Pro Bono session through Mrs. Mahima Khera and Mrs. Sneha Sharma from the Ministry of Law and Justice, Government of India on 17th December 2022.

The NyayaBandhu (Pro Bono Legal Services) is the Government of India's primary initiative is to establish a framework for dispensation of pro bono legal services across the country. Being Established under the NyayaBandhu Scheme, which strives to instill a sense of duty toward the underprivileged and unaided, is a matter of great honour for the Department of Law, MAIMS. The Nodal Officer, Dr. Nisha Dhanraj Dewani, stated that since September 2022, two activities have been held, namely, book distribution in partnership with the Legal Aid Services Clinic of MAIMS and a blood donation camp in partnership with the RML Hospital, Youth Red Cross, Legal Services Clinic, and NSS Cell of MAIMS.




Ms. Sneha (Project Manager), spoke about the mission statement, as well as the function and significance of pro bono. She provided a thorough description of the Pro Bono Club, the significant projects undertaken, and a look at the Department of Law's official website, which is run by the Union Ministry of Law and Justice. Under NyayaBandhu, qualified marginalized beneficiaries are connected with practicing attorneys who are interested in volunteering their time and talents using mobile technology. Together with technical partner CSC e-Governance Pvt. Ltd., the NyayaBandhu Mobile application (Android/IOS) was created and added to the UMANG platform.

Ms. MahimaKhera had a deep-down discussion with all the members about the Legal Literacy Initiative, which basically aims to empower the poor and disadvantaged sections of society to seek and demand justice services.

The Program also seeks to improve the institutional capacities of key judicial service providers to enable them to effectively serve the poor and marginal sections of the society.








Ms. Sneha also mentioned that the Department of Justice has formulated a scheme on Access Justice named 'Designing Innovating Solutions and Holistic Access to Justice (DISHA)' to be implemented during the period of 2021 to 2026. DISHA aims to merge different Access to Justice (North East & Jammu and Kashmir) programs being implemented by the Department of Justice while simultaneously upscaling them to all India level. One of the key objectives of DISHA implementation of Pan India Legal Literacy and Legal Awareness Program.

The Pro Bono Club also showcased the NUKKAD NATAK "PRATIBANDH" gesture by the Pro Bono club students, which highlighted the different eye-

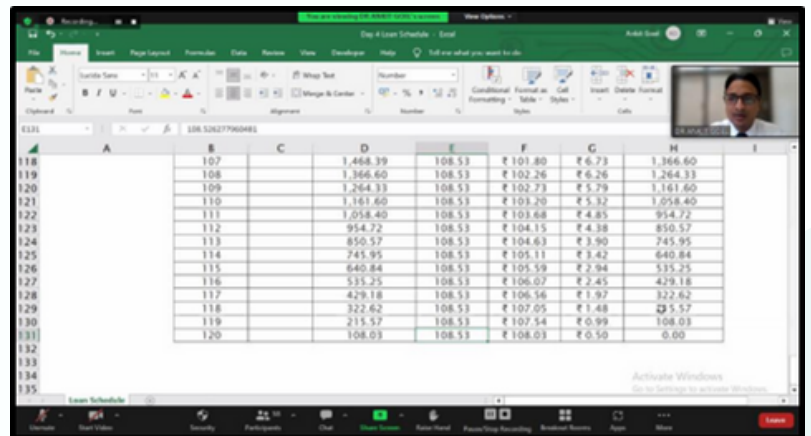
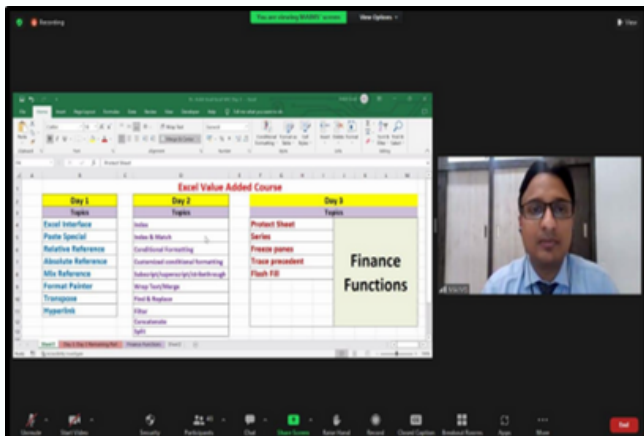

# VALUE ADDED COURSE ON MS EXCEL 5TH DECEMBER 2022- 16TH JANUARY 2023

The Department of Law organized yet another Value Added Course on MS Excel. The Course was inaugurated on 5th December by our HOD Dr. Praveen Kumar Gupta. Students have to keep themselves well-versed with latest technological changes. However there are certain tools which are evergreen and widely used in all types of jobs. MS Excel is certainly one of them.

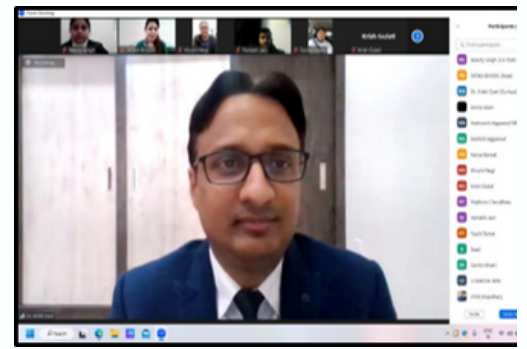
The first session was conducted on 5th December, 2022 by Dr. AnkitGoel, Associate Professor, Department of Law, MAIMS. The topic of the session was "Making Familiar with Basics of Excel" which was elaborated thoroughly by discussing various ways to perform a function as there are unlimited functions in MS Excel. He explained about Google Sheet, Ribbon, Windows and usages of formulas.



The second session was conducted on 7th December 2022 by Dr. Ankit Goel on the topic "Explore functions in Excel for making Daily work Easy." He discussed Index Formula and usages of tables, conditional formatting, and new formatting rules.

The third session was also conducted by Dr. Ankit Goel on 9th December 2022 on the topic "Finance Functions". The concept of Protect Sheet and Translation Functions were explained. Series option, Freeze Panes, Trace Precedent which helps in knowing the formula as well as evaluating the formula and flash fill were explained. He also spoke about finance functions which included calculating future value for lump sum investment, periodic investment and compounding period and then present value for annuity investment.

Resource person for the fourth session was again Dr. Ankit Goel and the topic of the day was "Loan Schedule". Loan schedule is a statement which gives information about Principle and Interest at a particular point of time. Then he moved to Secrets and Tricks of Excel. Tricks like Convert data into large or small font (using font, using formula), show picture along with cell, float message with data entry, copy different cells and paste at one different sheets, keep header data in center without merge, convert data into table format in one click, hide data etc.



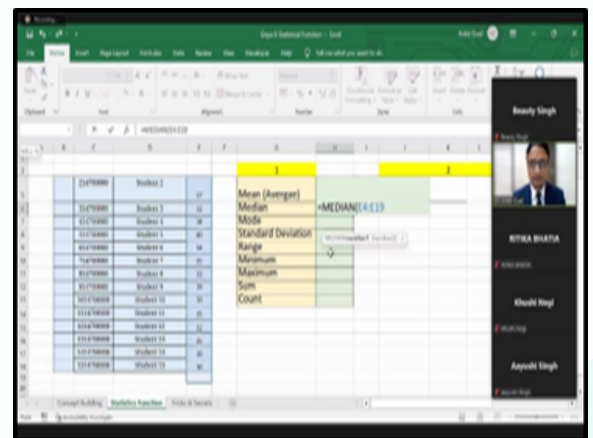
In the fifth session which was held on 14th December 2022, Dr. Ankit Goel spoke on the topic "Mathematical Functions for Data Handling". He started with the basic math functions in excel and also taught students about Round /Round up /Round down/M round feature of excel.

After that he moved onto one of the most important features of excel i.e., random number generate. Then next concept for the day was count, count A, count if, count ifs, count blank,etc. which helps in knowing the formula as well as evaluating the formula and flash fill which helps when you are working on a data.

The sixth session of the Value added course was held on 15th December 2022 in which the Resource person Dr. Ankit Goel spoke on the topic “Statistical Functions for Data Handling”. He explained about the basics statistics function in the MS

Excel. With this he continued explaining how to use Product, Power, Mean, Median, Mode, and use of mathematical symbols the participants took keen interest in the session by asking various questions and clearing their doubts from the speaker.

Seventh session was held on 19th December and the topic of the session was “Accounting Functions in MS Excel. “He explained about “Subtotal” and concepts like depreciation, aggregate, and how to calculate weekday and weekend in excel. Dr. Ankit also explained about various shortcuts of MS Excel like how to add rows, columns, move a cell in any of the directions, create charts instantly, and many more. The whole session was thoroughly explained by giving adequate examples.



The eighth session was conducted on 21st December 2022 by Dr. AnkitGoel and he spoke on the topic "Charts & Pivot Tables" in which he explained about ways to insert a chart in MS Excel sheet. He explained about Shortcuts, Bar Chart, Histogram, Pie Chart and Line Graphs, ways to convert simple data into advanced graph. Students were given Hand-on demonstration.

The ninth session was conducted on 24th December 2022 and the resource person was Dr. Nikhil Kaushik, Sr. Assistant Professor, Finance in AIT, Chandigarh University. The topic was "Logical Functions". He kept the session lively and interesting by giving away various activities and exercises to the students. He explained the concepts of "Data Validation" and "V Lookup".

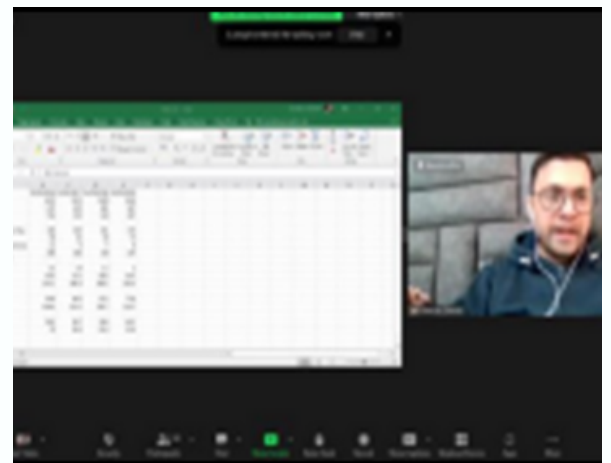

And lastly, to give a better idea about the same he used adequate examples using the balance sheet of Reliance to give better clarity and practical understanding.

The twelfth informative session of MS- Excel started with a warm welcome and introduction of the resource person for the day, Dr. Gaurav Dawar Assistant Professor at Christ (deemed to be University) the topic for the session was Financial Modelling. The esteemed speaker started the session with giving a brief introduction of the topic- Financial Modelling with the help of a hypothetical example. He explained the concept with the help of the income statement and balance sheet as an example. He started solving the example by telling the formulas and tricks of excel and gave the projections and assumptions to the example.

He very well explained to participants how financial modeling is helpful in analyzing the trends of the company.

The Thirteenth session of the VAC took place on 29th December 2022 e was a great success too. The session commenced with a generous welcome of the esteemed speaker for the day, Dr. Gaurav Dawar, Assistant Professor at Christ (deemed to be University) Sir started with a previous example of last session, he first gave a brief about the last session and continued further. He completed the estimated balance sheet which he had started in the last session. After that he made the cash flow statement with the help of a balance sheet and income statement. He clarified all the doubts of participants. The session ended by granting a vote of thanks to the esteemed speaker.



The fourteenth elucidate and informative session of MS- Excel took place on 30th December 2022 with the Quiz Guidelines for the quiz to be held on the Valedictory Session by Ms. Ritika Bhatia. The topic for the fourteenth session was Dashboard Marketing/HR/Finance and was conducted by Dr. Ankit Goel. The esteemed speaker started the session with the meaning of the topic for the day with the help of a dashboard and raw data for the same. He also apprised the participants on how to import the data with the help of Google Sheets. The step way manner on how to effectively create a Dashboard was explained by the speaker. He gave various information on how to add logo, use controls, use scorecards, etc. Furthermore, he explained how to add various graphs and charts and also the difference between Dimensions and Matrix.

● Unmarried and single women have right to safe abortion [Health and Family Welfare Department, 2022 SCC Online SC 1321, decided on 29-9-2022]

● The acquittal in a criminal case would not automatically entitle a candidate for appointment to the post. [ Satish Kumar Yadav v. Union of India, 2022 SCC Online SC 1300, decided on 26-9-2022]

● In the 2018 horrific case relating to the abduction, rape and murder of eight year old girl in Kathua district of J&K by six men and one accused claiming to be a juvenile at the time of the incident, the bench of Ajay Rastogi and J.B. Pardiwala J.J. has held that the respondent accused was not a juvenile at the time commission of offence and tried the way other co-accused were tried in accordance with law.

● Bound to protect Constitutional rights of women, the Calcutta High Court regularizes domestic violence applications filed by the minor.

● Delhi High Court grants Rs. 2 Crore compensation to ADOBE in a trade mark infringement suit against a cyber squatter.

● J&K and Ladhakh High court refuses to quash FIRs against the media outlet "Kashmiriyat " and " Kashmir Walla " for publishing an article alleging use of force

● President of India, Hon'ble Mrs. Draupadi Murmu has appointed Shri Justice Dipankar Datta as Judge of the Supreme Court.
