1. SCOPE OF COLLABORATION

- 1.1. General Scope. Each institution may offer to the other opportunities for activities and programs, such as teaching, research, exchange of faculty and students, and staff development that will foster a collaborative relationship.
- 1.2. Specific Activities: The purpose of this MOU is to develop academic and scholarly partnership through means of various programmes and activities and to promote mutual cooperation between the two parties to further promote their individual mandates.

- 1.2.4 Any other programmes to be mutually agreed upon.

2 RECOGNITION, RENEWAL, TERMINATION AND AMENDMENT

2.2 Recognition:

Each party to this MOU acknowledges the Centre of Excellence established by respective universities and extends recognition for their research and academic activities.



- 2.3 Duration: This MOU shall remain in force for 5 years from the date of the last signature. Either party may terminate this MOU by providing 30 days' advance written notice to the other party.
- 2.4 Extension and Renewal: The parties may extend or renew this MOU by agreement, confirmed in a written amendment signed by each party's authorized signatory.
- 2.5 Amendments: No amendment of the terms of this MOU will be effective unless made in writing and signed by each party's authorized signatory.

3. JointConferences,workshopsandshort-termcourses

Department of Law, MAIMS and faculty of Law, UDF agree to help identify and invite faculty members from the other institution toparticipate in conferences, workshops and short-termcourses. This Memorandum of Understanding (MOU) is hereby made and signed by The Faculty of Economics, Thammasat University, Thailand, and Thammasat Business School, Thammasat University, Thailand (hereafter referred to as TBS) and Maharaja Agrasen Institute of Management Studies and The University of Danang - University of Economics and Faculty of Economics & Business Administration, Dalat University. Thereinafter they will be individually referred to as "Party" or "Institution" and collectively referred to as "Parties" or "Institutions".

This Memorandum of Understanding aims to establish programs of research exchange and collaboration in areas of interest and benefit to the institutions. This agreement will serve as a general framework for cooperation among the institutions and is intended to facilitate discussions of more specific programs of collaboration. In particular, the institutions agree to promote the following collaborations:

- 1. Exchange of students, researchers and staffs (excluded TBS);
- 2. Coordination of such activities as joint research, lectures and symposia;
- Exchange of data, documentation, and research materials in fields of mutual interest;
- 4. Other mutually beneficial projects.

Director General Maharaja Agrasen Institute of Management Studies Sector-22, Rohini, Delhi-86 The implementation of specific programmes or projects under the above areas of cooperation will need to be negotiated on a case by case basis and be dependent upon the availability of funds and resources. Each specific programmes or projects will be covered by separate agreements between the institutions.

A designated person at each institution shall oversee and facilitate implementation of this agreement in cooperation with other appropriate administrators at the respective institutions.

The scope of activities under this agreement shall be determined by the funds regularly available at institutions for the types of collaboration undertaken and by such other financial assistance as may be obtained by either institution.

The present Memorandum comes into effect from the date of its signature by THE PARTIES and will remain valid for the period of 5 (five) years. Any institution wishing to terminate this agreement shall notify the other institutions in writing at least 6 (six) months prior to termination. In such case, exchange students and staff shall be permitted to complete the period of study or individual activities for which they are enrolled or assigned. The other agreements between the institutions that are established under this MOU shall not be affected in the event of this MOU being terminated. Any decision to renew or renegotiate the terms of this agreement shall be made on the basis of consultations among the institutions.





ARTICLE 4: Areas of Students activities

This MoU provides opportunities for the exchange of students and Ph.D scholars nominated by the respective Institutions in order to carry out studies as provided for in this agreement including internships.

The participating students will continue as students for degrees of their parent Institution, and will be enrolled as affiliate (or non- award, non- degree) students in the host institution.

ARTICLE 5: Implementation

Implementation of exchange or other kinds of cooperation based on this agreement shall be the concern of the relevant faculties or departments on a case to case basis. A specific plan shall be worked out for each joint activity. This plan shall ensure that appropriate arrangements for studying, working and for living and maintenance expenses are made before the arrival of a faculty member or a student to the host institution.

ARTICLE 6: Cost & Financing of Cooperation

Both the institutions will seek funding for the link programme from various sources. The acquired funds will be subject to accounting procedures of the two Institutions. The collaborating institutions will offer logistic support for initiating the collaboration and for working out draft proposals for the activities. Both parties understand that all financial arrangements are to be negotiated and will depend on the availability of funds.



- d. Provide a training session on mediation advocacy skills for newly admitted advocates:



CHAPTER 4

Count your Blessings: Gratitude and its Role in Enhancing Self -Esteem & Resilience Among Under Graduate Students

-Puja Khatri & Dr. Sumedha Dutta

Abstract: Positive psychology has ushered a new wave of interest towards understanding the biological, social and psychological bases of human emotions. As the intricacies of diverse emotions are further untied, gaps in understanding are exposed. One of the most apparent of those gaps relates to the construct of gratitude, which has undoubtedly stimulated the thinking of many theological and philosophical writings. Scholars label gratitude as the most unstudied emotion, despite having established its supremacy in normal functioning in philosophical and theological accounts. Also, in the present era we are taking more stress than is good for our sense of well – being. Under graduate students experience stress and anxiety during their times in a new learning environment, especially, after moving away from their cocoon - school life. Resilience determines how well an individual copes with a transition. Since, under graduate students also have to go through this transition; the researchers want to study the role of resilience in this context. It is observed that a high level of self – esteem of a student, increases his confidence, his self – worth and this in turn, further, strengthens his or her resilience. So, we suggest that students with low self – esteem will be less resilient towards their efforts in recovering from stressful events in compared to students with a high level of self – esteem. Does gratitude help college students to recover from adverse situations and what is the role of self – esteem in this relationship? Is resilience dependent upon gratitude and self – esteem? This is another aspect that will be explored in the present work.

The present work provides a theoretical framework to study the role of gratitude in building self-esteem and resilience among under graduate students. The paper also provides significant guidance as to how to implement psychological interventions aimed at strengthening under graduate's resilience.

Keywords: Gratitude; Positive Psychology; Resilience; Self-Esteem.

Introduction

In the past decade, a notable development in the field of psychology has been the surfacing of a broad perspective, named, positive psychology. The 'positive' branch harmonizes, without substituting or overlooking, the conventional areas of concern of psychology. The emergence of positive psychology has transformed the focus of researchers by igniting their interest towards the study of psychological phenomena. Positive psychology stresses that undivided focus on disorders will result in understanding a person's condition only at the surface level (Peterson, 2009); the root – cause(s) of the problem will still remain unattended. Moreover, positive psychology focuses on constructs such as wellbeing, flow, mindfulness, happiness, personal strengths, creativity, wisdom, etc that helps an individual to successfully fend for himself in this competition – driven world. In other words, just like the bird phoenix rises from its ashes, the application of positive psychology rejuvenates the soul of a blistered body. It doesn't solely aim on making individuals happy and thereby propagate a narcissist approach; rather it aims on spreading happiness and flourishing at group level as well. Thus, positive psychology is the study of how human beings thrive in the face of hard-ships (Seligman & Csikszentmihalyi, 2000).

Complexities and set-backs have always seen an uphill in amidst of diverse range of challenges, such as global warming, economic recession, political upheavals, terrorism, natural calamities, etc. These endless events act as an agent in ushering new developments in the field of Positive Psychology. One such construct of positive psychology that is yet to attain its legitimate stature is 'gratitude'. Scholars (McCullough, Emmons & Tsang,2002; Wood, Joseph & Linley, 2007) label it as the most unstudied emotion, despite having established its supremacy in normal functioning in philosophical and theological accounts (Emmons & Crumpler, 2000). In fact, in the prominent Aristotle's lists of virtues, gratitude doesn't occupy any place. Apart from its ignorance, various contemporary trends have also made the time ripe for empirically establishing the significant nature of gratitude. Psychologists who have devoted themselves to attaining the real purpose of positive psychology are quite interested in surfacing those psychological propensities which makes the life richer and as stated by Dietrich Bonhoeffer (1967) ... it is only with gratitude as one of the identified propensities that makes the life fuller. Also, the resurgent attention towards virtue ethics, a sub-branch of moral psychology, which considers gratitude as an essential ingredient for the moral personality (Hurtshouse, 1999; Taylor, 2002), is responsible for making it a promising time for gratitude. Moreover, the renewed concern of social scientists in people's religious and spiritual lives which has gratitude at its roots, has also prompted the researchers to dwell on this





I hope you are doing well.

Mittal & Associates welcomes you all to the Online Internship Program.

As you all know that due to Covid-19, the courts are presently closed for Regular work and only Online hearing of urgent matters is being done.

So, I am giving you facts of a case and you all have to research for the law available on this point.

A family consisting of A (father) and B, C, D, E, F and G (six sons) purchased a property in joint names of all the seven persons with equal share in 1961. Thereafter in 1965 Father A sold his 1/7th share in the property to all the remaining Six co-owners by virtue of a Registered sale deed and B, C, D, E, F and G became owners of 1/6th equal shares each in the said property. In 1966, one brother B also sold his 1/6th share in the said property in favour of all the remaining 5 co-owners by Registered Sale Deed. Now C, D, E, F and G became owners of 1/5th shares each in the property. Thereafter in 1983 two brothers C and D executed a Registered Relinquishment Deed separately, thereby relinquishing all their rights, title and interest in the said property in favour of E and by virtue of this, E became owner of 60% while F and G remained owners of 20% each in the said property. As regards the possession is concerned, E is having possession of only about 15% while the remaining 85% is occupied by F and G.

In 1985, E filed a suit for Partition by Metes and Bound and also for Possession with respect to 3/5th i.e. 60% share in the said property thereby impleading F and G besides C and D, who have already relinquished their shares in favour of E. During the trial, C and D also admitted the execution of Registered Relinquishment Deed in favour of E but wriggle out while filing written statement. However, in Income Tax and Wealth Tax Returns, C and D never shows their share in the said property after 1983. The Ld. Trial Court, though admitting the execution of Regd. Relinquishment Deed by C and D in favour of E but hold that the Relinquishment Deeds have been executed to avoid and payment of stamp duty thereby holding that all the five brothers are entitled for 20% shares each in the said property.

Now E filed an appeal thereby challenging the finding of the Ld. Trial Court on the point that when C and D have admitted the execution of seperate Regd. Relinquishment deed in his favour, then court should have allowed 60% share in favour of E and 20% each in favour of F and G.

You have to research on this point that after execution of Regd. Relinquishment Deed by C and D in 1983 in favour of E and thereafter C and D admitting the execution thereof in the written statement filed before the court and further not showing themselves as co-owner in the Wealth Tax Returns filed before the Income Tax authorities, E should have been held entitled to 60%.

I am giving you all an opportunity to research on this point that E is entitled for 60 % right/share in the property.

In case any of you want to discuss any thing more on this aspect, you are free to call me at any time between 10 AM to 7 PM on any working day.

We shall also meet personally as and when the lock down is lifted.

ABC & Co. owned by A was also having one concern with the name of ABC only having office in Delhi. All the transactions for supply of goods from Dubai also took place in Delhi office. ABC & Co. failed to supply the goods to X and also failed to refund the advance amount. Later on A issues a cheque from Delhi firm in favour of X for Rs. 10 Lakh which was dishonoured on presentation. Complaint u/s 138 filed against ABC wherein besides ABC in personal capacity being signatory, his concern ABC only and ABC & Co. were also arrayed as accused. Now A claimed that ABC only has no liability towards X, which issued the cheque. Liability was outstanding against ABC & Co. Dubai only. But admittedly A is authorised person to sign the cheque in both the concern i.e. Delhi concern ABC only and Dubai concern ABC & Co.

You have to search for the law that A is liable for the offence under section 138 of the Negotiable Instrument Act for the cheque issued by A (authorised signatory) from ABC only but liability outstanding against ABC & Co. Dubai.

INTRODUCTION

The macroeconomic aspects of performance of any sector pertain to its contribution to the capital formation. national output, employment, fostering of a culture of innovation and national competitiveness in the global context. In India, the presence of corporate sector essentially is in the industrial and services sector and as such structurally it contrasts with the unincorporated or informal sector of India's industrial and services sector. The latter abounds numerically; wields little economic power; struggles for domestic and foreign capital despite contributing substantially to GDP. industrial production, national employment and exports. STRUCTURE OF THE SECTOR
