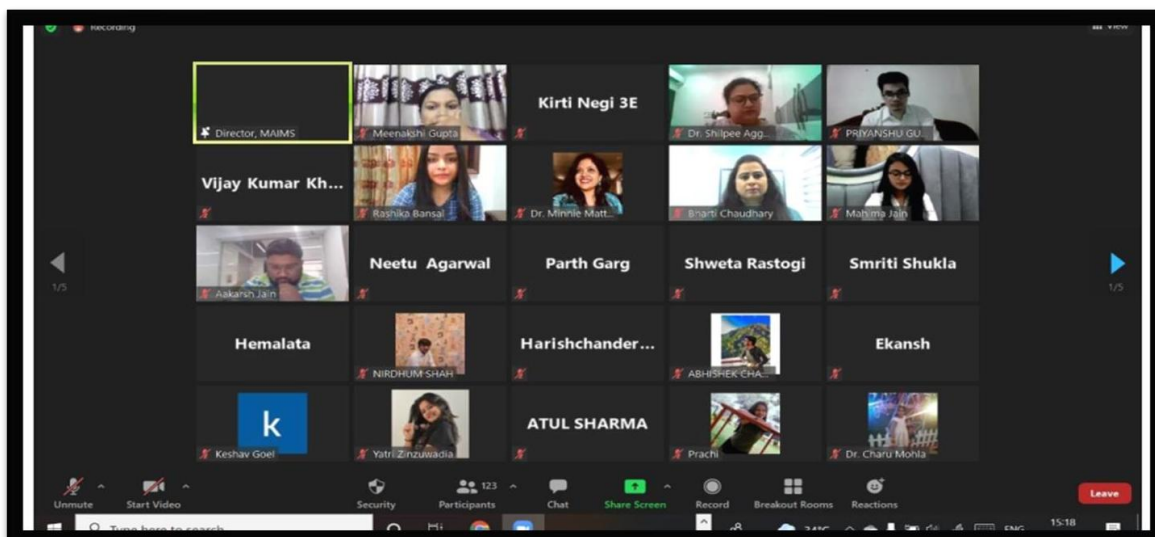

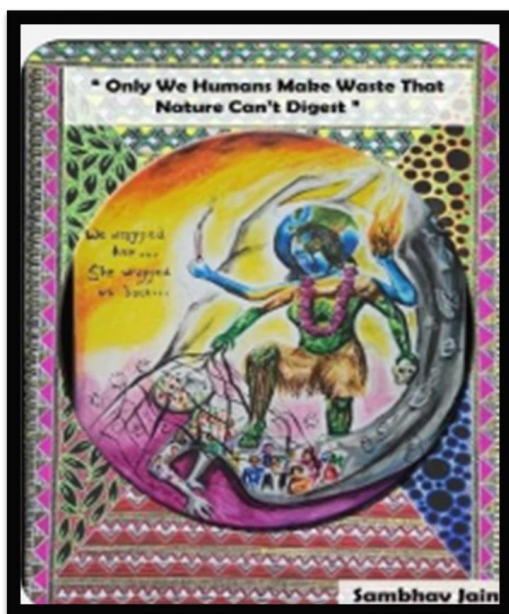
The Discussion was a cohort of scientific, technical, academic and judicial experts deliberating together in churning out solutions that meet the desired results namely
