2021-2022

Green Audit, Energy Audit and Environment Audit are conducted in Maharaja Agrasen Institute of Management Studies by Zing Enterprises, Bhiwadi, Rajasthan in the academic year 2021-2022. As per the report of the auditing agency, the following actions are taken:

- Regular tree plantation drives were organised under the activity ‘Paryavaran Raksha Parv’, which has become an annual event of MAIMS.
- Lush green lawns with variety of medicinal and seasonal flowers are blooming across the campus.
- The institute has already adopted the DDA Green belt adjacent to the institution and has been maintaining the same which has become lush green area a heavenly abode for birds and a close to nature experience for surrounding community.
- The institute has adopted a strict policy for restricted entry of vehicles; wherein only vehicles with authorised entry pass are allowed inside the campus.
