



The speakers for the workshop wereMr. Arpan Sharma, Deputy Director Competition Commission of India and Ms. Deepa Ojha, Deputy Manager Data Security Council of India.



Mr. Arpan Sharma has been working as Deputy Director (Law) at the Competition Commissionof India since 2018. Prior to this, he worked with General Insurance Corporation of India, Mumbai, for about 3 years and with Delhi Metro Rail Corporation for more than 1 year. He hashad exposure to litigation in High Court and District Courts in Delhi for close to four years. Ms. Deepa Ojha is Deputy Manager (Policy and Privacy) at DSCI. She is a legal professional working in the policy domain of emerging tech, cyber security, and competition with an overarching focus on data privacy, cyber security and national security requirements vis a vis cross border data flow.
