PARLIAMENT VISIT BY THE STUDENTS OF BBALLB (6TH JANUARY 2023)

Maharaja Agrasen Institute of Management Studies, Department of law organized a visit to the Parliament of India on Friday, 6th January, 2023. This visit was organised for third semester students of BA LLB and BBA LLB, Batch 2021-2026, being a part of PSDA of Constitutional law.

A total number of 52 students were accompanied by the faculty members of the department of Law-- Dr Deepa Kaushik, Dr Mukesh Kalwani, Ms Preeti Goel and Mr Rakesh Chaurisa, PRO visited the temple of Democracy- Öur Parliament.

The Parliament of India is the supreme legislative body of the Republic of India, It consists of two houses, i.e. Lok Sabha and Rajya Sabha.

With great zeal and enthusiasm, the students along with the faculty members entered the parliament complex through the parliament house museum gate after completing all the formalities. The group was welcomed by the officials followed by an insightful address by Mr Raj Kumar, Additional Director, PRIDE (Parliament Research And Training Institute For

Democracies), who presented a brief introduction through a documentary about our lawmaking process.


Then they proceeded for a guided tour and witnessed the replica of the Constitution of India in the Library of the

nation in 1947, a significant milestone that marked the nation's historic transition to freedom). The students and faculty took the opportunity of sitting in the public gallery of both houses. The Personnel at both the houses very efficiently explained the intricacies of different halls and elaborated upon interesting facts about the structures and the galleries to the students. Various queries of the students about the historical and legal aspects were also addressed by the tour guides. The students expressed their gratitude to Dr. V.K. Bhatnagar, faculty members and the management of the Institute for organizing such an enlightening academic visit which helped the students to gain in depth knowledge about the Indian legislative process and functioning of

Parliament of India.

The Aim of this was to sensitise the students about the social evil of Acid Attack that still persist in our country. By giving real life examples and situations he made the interaction more interesting. He also mentioned about various articles of the Constitution which provide protection to the injured like Article 15(3); article 200; Article 300; Article 307; Article 302 etc

INAUGURATION OF IPR CENTER & WORKSHOP ON INTELLECTUAL PROPERTY RIGHTS: AWARENESS AND PRACTICE (1ST MARCH, 2023)



The Department of Law Maharaja Agrasen Institute of Management Studies, GGSIPU, Delhi commemorated the inauguration of its IPR Center via a Workshop on Intellectual Property Rights: Awareness & Practice, which was held on Olst March, 2023 (i.e., Wednesday) from 10:00 a.m. onwards.

The Inauguration and Workshop was done in the esteemed presence of multidisciplinary legal fraternities, wherein Dr. Claudia Masoni, Researcher, University of Waikato, NewZealand Ms. Chhavi Garg, Examiner of Patents and Designs, Ministry of Commerce and Industry, Government of India; Mr. Naveen Mathur, Joint Controller of P&D, Office of the Controller General of Patents, Designs & Trade Marks, Ministry of Commerce and Industry, Government of India; and Dr. Raghavender G.R., Former Joint Secretary, Ministry of Law & Justice, Government of India; presented insights relating to their domain of study.

The event was also graced by the presence of Prof. (Dr.) Rajni Malhotra Dhingra, Director, MAIMS; Dr. Praveen Kumar Gupta, Head, Department of Law and Dr. Nisha Dhanraj Dewani, Associate Professor, Department of Law along with Faculties and students of various departments of MAIMS. The event was attended by more than 120 participants.

started with programme which "Saraswati The Vandana" commenced with a fervent and soulful Saraswati Vandana was subsequently followed by the Introductory Remarks of Dr. Praveen Kumar Gupta, Head, Department of Law,. His observations took the audience a deep dive into the importance of IPR, analysis of India's GI Index being a global manufacturing hub, a need for more patent and design claims as compared to other countries, and such similar notions so as to protect the IPR of India. Subsequently, Dr. Raghavender G.R., Former Joint Secretary, Ministry of Law & Justice, Government of India discussed regarding the 3 pillars legislation, management, **IPR** (being strong of and awareness), its registration enforcement of **IPR** and commercialisation, governmental policies, public funded research bills, and conventions (such as Geneva and Paris Conventions) acting in harmony to each other.



He also emphasized on how recent human-made technology/AI such as ChatGPT is causing IPR infringement with single and multiple sources of plagiarism which cannot be scrutinized by Turnitin as well.

Subsequently, Mr. Naveen Mathur, Joint Controller of P&D, Office of the Controller General of Patents, Designs & Trade Marks, Ministry of Commerce and Industry, Government of India elaborated with future of patents and designs, and increase in stakeholders being congruent to dynamic technologies, thus making it onerous to grant a patent, which can only be resolved if the present-day policies and laws are comprehensive enough.

The First Technical Session was led by Dr. Claudia Masoni, Researcher for Traditional Knowledge, University of Waikato, NewZealand on "Indigenous Traditional Knowledge & Biopiracy". She deliberated that 'Law is neither fair, nor just', and is just a consequence of misuse of engaged audience the with discussion Traditional/Indigenous Ecological Knowledge (TEK) and Biopiracy, Laws on Patents, TRIPS Agreement [A.27(3)(b)], Several Conventions (such as CBD, UNDRIP, ICESCR, UDHR, etc.), and specifically on how Human Rights of Indigenous People and their common heritage are being violated in consideration to IPR, wherein the same can be protected by listening to them, judiciously communicating with them, and by protecting indigenous customary laws. She inspired the audience by quoting M. Gandhi, "You must be the change you wish to see in the world".

The Second Technical Session was steered by Ms. Chhavi Garg, Examiner of Patents and Designs, Ministry of Commerce and Industry, Government of India in respect to NIPAM (National IP Awareness Mission), wherein her presentation revolved around the concept of Patents and Designs as to 'Patents are granted, however rest are registered'. Her pedagogy involved its introduction, examples, obtaining criteria, exceptions, steps of filing (Patent and Designs Application Processing), essential forms, prescribed fees, timelines, certification, etc.

Introduction and importance of other pertinent IPR regimes such as Trademarks, Copyrights, Geographical Indication (GI), Semi-Conductor Integrated Circuits Layout-Design (SICLD), Plant Varieties and Farmer Rights Act, along with Biodiversity Act were also took up for its summarised analysis. Thereafter, audience's reservations were took up for on-spot discussion and an interactive quiz was conducted wherein students were appreciated with prizes for correct answers.

Eventually, the Inaugural Event came to a favorable conclusion by the Vote of Thanks delivered by Dr. Nisha Dhanraj Dewani, Associate Professor, Department of Law, MAIMS, wherein she expressed unfeigned gratitude to all the dignitaries and luminaries for marking their presence and contributing their valuable time towards the inception of MAIMS IPR Center, a germinating yet distinctive asset to the family of Department of Law, MAIMS.

VISIT TO THE CAW CELL (10TH MARCH 2023)

Maharaja Agrasen Institute of Management Studies, Department of Law was invited by District Legal Services Authority to visit the CAW cell of Rani Bagh Police Station on account on Women's Day to spread awareness and knowledge among the students about the functioning and purpose of DSLSA on 10 March 2023.

Through the entire visit of CAW Cell Rani Bagh, SI Veena ma'am along with ASI Lalita ma'am and Reader sir helped to understand what CAW Cell has been made for and what is its functioning. works.

In Brief CAW CELL is Crime Against Women Cell. Trained counsellors in the cell help women (married women) facing violence and matrimonial related disputes or any matter related to maintenance by providing them emotional support, assisting them with counseling sessions.



VISIT TO TIHAR JAIL (7TH MARCH 2023)

The Department of Law, in collaboration with North West District Legal Services Authority organized a Visit to Tihar Jail on the eve of Women's Day on 7th March, 2023. Advocate Chaman Lal, North West District Legal Services Authority along with The Legal Aid Convenor, Ms. Purnima Gupta started the visit with the student. As the students entered the jail no. 6 (WOMENS JAIL) firstly they saw the mulakat room where prisoners meet their family members in physical mode or through electronic media. Students learnt about the rules related to meeting of prisoners and the evolvement of electronic media. They also saw the legal aid room and court room where lawyers from DLSA of High court as well as District courts visit on daily basis to help prisoners in their court proceedings. Further, students also came to know about various duties performed by the prisoners like handmade dresses, sweaters etc. Some work in kitchen making gujiyas, ladoo, matthi etc for the occasion of Holi and many other tasks they perform for which they are provided with some amount in form of salary for their work. Students also came to know that prisoners are only allowed to spend Rs. 7000 monthly and rest of their earnings are saved for their future.



There was also a crèche room where children of 0-6 years are provided with all the facilities such as good nutritional food, playing area, television, studies, nap time etc showing that their future is not compromised. Students also saw medical room and the pharmacy with all medical facilities the needed. Overall, the visit was very exciting and informative. It was a great exposure for the students to see the condition of people in cells and at the same time they could see the specific rights available to them while serving imprisonment too.





MAIMS' Alternative Dispute Resolution Cell (ADRC) organized its 3rd Justice J.S.Verma Memorial ADR & Client Counseling Competition from March 22nd - March 25th & 1st April, 2023 and NAVITAS - MAIMS 3rd National Law Fest, 2023. This event was conducted in collaboration with the family of Justice J.S.Verma, FSRI- Foundation for Sustainable Rule of Law Initiatives based in California, USA and sponsored by Asian School of Cyber Law and Union Bank of India.

The Inaugural Ceremony for this entire 5-day event was a grand affair held at the NDMC Convention Centre, New Delhi on 22nd March, 2023 and graced by Hon'ble Mr. Justice Jitendra Kumar Maheshwari, Judge, Supreme Court of India and Hon'ble Mr. Justice Satish Chandra Sharma, Chief Justice, Delhi High Court.

MAIMS 3rd Justice J.S. Verma Memorial National ADRCC Competition sought to encourage the effective use of alternative dispute resolution mechanisms and included four competitions namely- Mediation Competition, Negotiation Competition, Client Counseling Competition. Along with the event, a workshop on Mediation was held prior to the competition by Ms. Jennifer L. Brandt, an experienced Attorney, for all the registered participants. She has served as a Judge and Mediator at ABA and ICC Commercial Mediation Competitions.


