#### **REPORT**

On December 1st, the Internship & Placement Committee of the department of law, Maharaja Agrasen Institute of Management Studies organised a workshop skilfully led by Mr. Vishnu Dutt an expert in the field of digital forensics and investigation with an experience of 17 years in the field. His credentials include certification as an expert from Secure India, a prominent organization specializing in cyber security and digital forensics solutions, catering to governmental needs and beyond.

The workshop started off at 12:30 PM, with a warm welcoming note from Mr. Naman Sondhi. He also conducted a live experiment using strong hold bags to demonstrate how to control data capture, making it easier for everyone to understand and grasp the concept. Through these examples and practical demonstrations, attendees gained practical insights into these complex subjects. The workshop wrapped up with a doubt-clearing session. Students raised queries about various topics, seeking clarification, and sharing their feedback. Towards the end, a questionnaire round was conducted. Students who participated and answered the questions were rewarded with a desktop camera protection card.
