## Report on Training Session on Lexis Nexis Portal Usage

## Key topics covered

Advanced search filters enable users to narrow down results based on jurisdiction, date, or document type.
- Case Analysis Tools: Lexis Advance India offers tools for analyzing case law, which
  helps users validate the authority of case law and identify subsequent judicial treatment.
  Case headnotes provide concise summaries of key legal principles discussed in
  judgments.
