The MAIMS Moot Court Society, under the Department of Law, MAIMS organized the 4th Intra Moot Court Competition, 2024 with the Researcher's Test, singular Intra Induction Round scheduled between 20-22 February, 2024 and the Final Round on 07 March, 2024.

Overall, 87 Teams and 261 participants participated in the Competition from the Batch of 2028 in the present academic year from the integrated course of B.A. and B.B.A LL.B. (Hons.).

The Competition started with the Researcher's Test on 20 February, 2024, and was concluded by the Draw of Lots and Exchange of Memorials the same day. The Competition consisted of a single 'Intra Induction Round', between two teams at a time held through four different rounds in two days.

The Intra Induction Round was conducted on 21 and 22 February, 2024 wherein a total of 87 Teams from across the Batch of 2028 took participation. The Intra Induction Round was a knock-out round, from which the top two teams with highest aggregate score in Oral Submissions were advanced in the Final Round.
