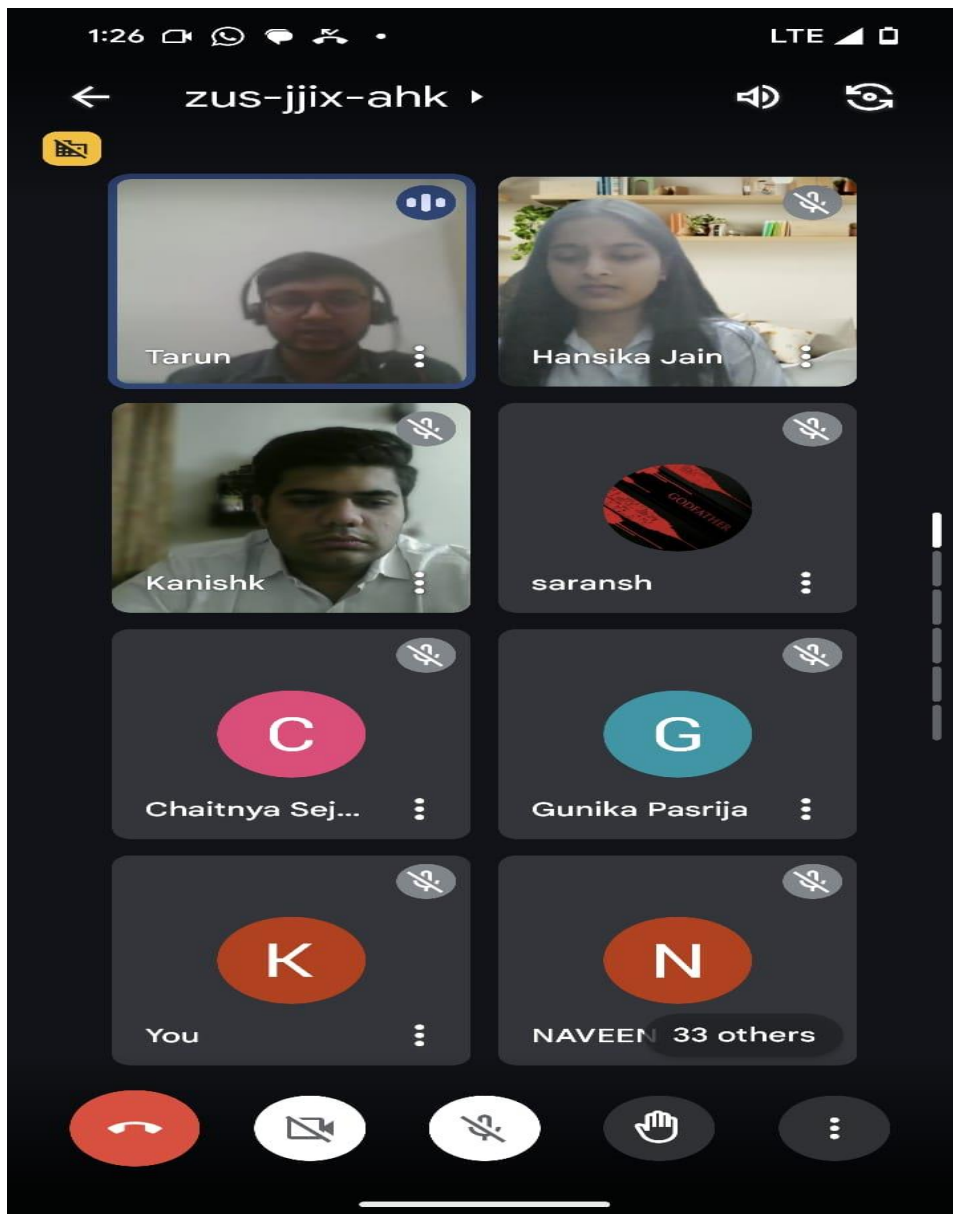

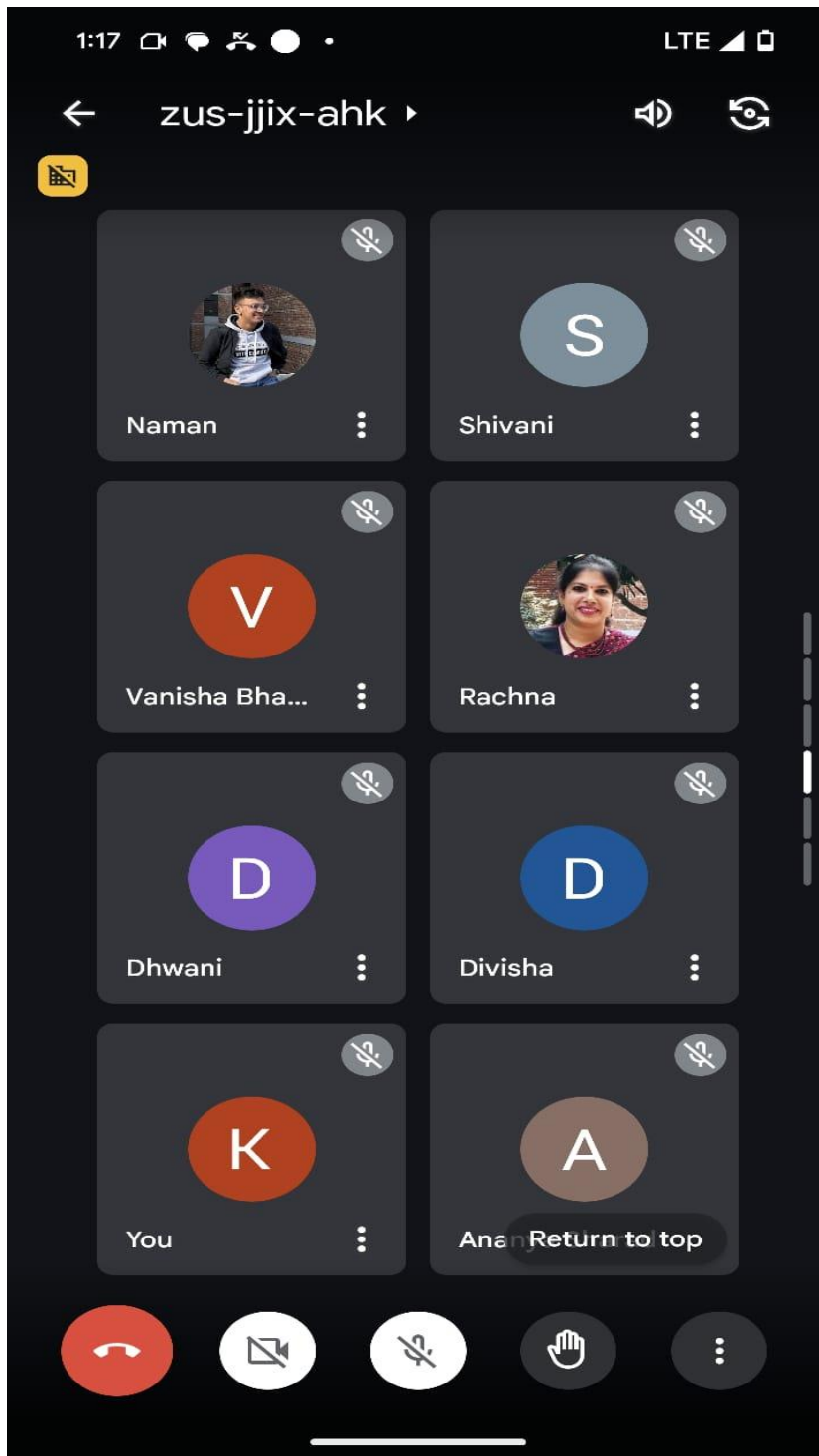
The event ended with presenting mementos to the guests by Head of Commerce Department, Prof. (Dr.) Manju Gupta as token of gratitude and respect
